3. Charity Objectives

MAH Charity exists to relieve hardship and poverty by providing charitable support to individuals and families in need. The charity's activities focus on providing essential food support to vulnerable families, including widows, orphan families and others experiencing financial difficulties.

4. Activities and Achievements During the Year

During the financial year, MAH Charity continued its charitable activities by providing food support to vulnerable families experiencing hardship in Pakistan. The charity worked with a supplier in Pakistan under a formal agreement. The supplier was responsible for preparing and purchasing food packs and arranging delivery of supplies on behalf of the charity to support orphans, widows and poor families in accordance with the charity's objectives.

Food support included essential items such as rice, flour, cooking oil, lentils and other household necessities as required. Payments made to the supplier were supported by invoices and supporting documentation, which were retained as part of the charity's records.

5. Public Benefit

The trustees confirm that they have considered the Charity Commission's guidance on public benefit. MAH Charity provides benefit to individuals and families experiencing poverty and hardship by helping them access essential food supplies. Through its food support programme, the charity aims to improve the wellbeing and dignity of vulnerable people.

6. Financial Review

During the financial year ended 01 April 2026:

Total income: £2119.29

Total expenditure: £801.51

Closing funds: £1317.78

The charity's expenditure mainly related to charitable food support provided through the supplier arrangement in Pakistan and associated bank charges. The charity maintained proper financial records, and invoices, agreements and supporting documents were retained. The trustees are satisfied that funds have been used appropriately to support the charity's objectives. The charity had no outstanding liabilities at the year end.

7. Future Plans

The trustees plan to continue providing support to vulnerable families experiencing hardship and to develop the charity's activities in line with its charitable objectives.
