Objects: THE COMPANY'S OBJECTS ARE SPECIFICALLY RESTRICTED TO THE FOLLOWING:3.1 TO FURTHER OR BENEFIT THE RESIDENTS OF STORTFORD FIELDS AND THE NEIGHBOURHOOD, WITHOUTDISTINCTION OF SEX, SEXUAL ORIENTATION, RACE OR OF POLITICAL, RELIGIOUS OR OTHER OPINIONSBY ASSOCIATING TOGETHER THE SAID RESIDENTS AND THE LOCAL AUTHORITIES, VOLUNTARY ANDOTHER ORGANISATIONS IN A COMMON EFFORT TO ADVANCE EDUCATION AND TO PROVIDE FACILITIESIN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND LEISURE TIME OCCUPATION WITH THEOBJECTIVE OF IMPROVING THE CONDITIONS OF LIFE FOR THE RESIDENTS.3.2 IN FURTHERANCE OF THESE OBJECTS BUT NOT OTHERWISE, THE TRUSTEES SHALL HAVE POWER:3.2.1 TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A COMMUNITY BUILDING AND TOMAINTAIN OR MANAGE OR CO-OPERATE WITH ANY STATUTORY AUTHORITY IN THEMAINTENANCE AND MANAGEMENT OF SUCH FOR ACTIVITIES PROMOTED BY THE CHARITY INFURTHERANCE OF THE ABOVE OBJECTS; AND3.2.2 TO PROMOTE THE CONSERVATION, PROTECTION, MANAGEMENT, MAINTENANCE ANDIMPROVEMENT OF THE PHYSICAL AND NATURAL ENVIRONMENT.
