SUPPORT SUCH STUDENTS TO UNDERTAKE INTERNSHIPS OR PRACTICAL EXPERIENCE OPPORTUNITIES IN ARCHITECTURE, PLANNING OR SURVEYING WITH ORGANISATIONS HOLDING A RELEVANT PROFESSIONAL ACCREDITATION; C. SUPPORT ORGANISATIONS, INCLUDING ACCREDITED PROFESSIONAL BODIES, EDUCATIONAL INSTITUTIONS OR CHARITIES, WHO ARE UNDERTAKING RESEARCH INTO ARCHITECTURE, PLANNING AND SURVEYING, THE USEFUL RESULTS OF WHICH WILL BE PUBLISHED FOR THE PUBLIC BENEFIT.
