**Activities:** To advance Orthodox Jewish life through Chabad-inspired religious, educational, social and welfare activities; support elderly and vulnerable people facing hardship or exclusion; and assist youth in need through programmes that build skills, resilience, responsibility, volunteering and community cohesion.
