Objects: THE OBJECT OF THE CHARITY IS THE PROMOTION OF THE VOLUNTARY SECTOR FOR THE BENEFIT OF THE PUBLIC IN PARTICULAR, BUT NOT LIMITED TO, PROVISION OF SPACE, RESOURCES, ADVICE AND OTHER SUPPORT TO CHARITIES AND VOLUNTARY ORGANISATIONS WITHIN THE VOLUNTARY SECTOR SO AS TO IMPROVE THEIR SERVICES TO THE PUBLIC IN TERMS OF EFFICIENCY, EFFECTIVENESS AND QUALITY, FACILITATE AND DEVELOP NEW CHARITIES AND VOLUNTARY ORGANISATIONS TO MEET UNMET NEED, EXTEND THE ACTIVITIES OF CHARITIES AND VOLUNTARY ORGANISATIONS INTO NEW AREAS OF ACTIVITY WHICH BENEFIT THE PUBLIC, AND TO EXTEND THE PARTICIPATION IN THE VOLUNTARY SECTOR OF SECTIONS OF THE COMMUNITY WHO ARE UNDER-REPRESENTED WITHIN THE SECTOR. THE VOLUNTARY SECTOR MEANS CHARITIES AND VOLUNTARY ORGANISATIONS. CHARITIES ARE ORGANISATIONS WHICH ARE ESTABLISHED FOR EXCLUSIVELY CHARITABLE PURPOSES IN ACCORDANCE WITH THE LAW OF ENGLAND AND WALES. VOLUNTARY ORGANISATIONS ARE INDEPENDENT ORGANISATIONS, WHICH ARE ESTABLISHED FOR PURPOSES THAT ADD VALUE TO THE COMMUNITY AS A WHOLE, OR A SIGNIFICANT SECTION OF THE COMMUNITY, AND WHICH ARE NOT PERMITTED BY THEIR CONSTITUTION TO MAKE A PROFIT FOR PRIVATE DISTRIBUTION. VOLUNTARY ORGANISATIONS DO NOT INCLUDE LOCAL GOVERNMENT OR OTHER STATUTORY AUTHORITIES.
