TO PROMOTE THE ART AND SCIENCE OF WATER POLICY AND MANAGEMENT FOR THE PUBLIC BENEFIT, PARTICULARLY BUT NOT EXCLUSIVELY BY THE PROVISION OF EDUCATION, TRAINING, STUDY AND RESEARCH IN THE POLICY, SCIENCE AND MANAGEMENT OF WATER (AND SANITATION) AND THE PROMOTION OR PUBLICATION OF SUCH INFORMATION OR RESULTS.
