IN FURTHERANCE OF THESE OBJECTS BUT NOT OTHERWISE, THE TRUSTEES SHALL HAVE POWER: TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN OR MANAGE OR CO-OPERATE WITH ANY STATUTORY AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE CHARITY IN FURTHERANCE OF THE ABOVE OBJECTS. 2. TO PROMOTE CORNISH AND CELTIC ARTS, CULTURE AND HERITAGE AND TO EDUCATE THE PUBLIC ABOUT CORNWALL'S CONTRIBUTIONS TO ART, LITERATURE, AND INDUSTRY THROUGH DISPLAYS, EVENTS AND PERFORMANCES.
