TO PREVENT OR RELIEVE POVERTY OR FINANCIAL HARDSHIP BY PROVIDING OR ASSISTING IN THE PROVISION OF GOODS, SERVICES, AND PRACTICAL SUPPORT TO INDIVIDUALS AND FAMILIES IN NEED IN CORNWALL AND DEVON, PARTICULARLY THOSE EXPERIENCING ILL-HEALTH, DISABILITY, OR DISADVANTAGE
