**Objects:** 1. TO ADVANCE THE EDUCATION OF PUPILS AT FROXFIELD PRIMARY SCHOOL FOR THE PUBLIC BENEFIT, IN PARTICULAR BUT NOT EXCLUSIVELY BY: A. RAISING FUNDS TO SUPPORT THE DEVELOPMENT, PROVISION, AND MAINTENANCE OF MUSIC, ORACY AND PERFORMING ARTS FACILITIES AT THE SCHOOL; B. PROVIDING ACCESS TO EQUIPMENT, RESOURCES, AND LEARNING OPPORTUNITIES RELATED TO MUSIC, ORACY AND THE PERFORMING ARTS; AND C. SUPPORTING CURRICULAR AND EXTRACURRICULAR ACTIVITIES THAT ENCOURAGE CREATIVITY, ARTISTIC EXPRESSION, AND PARTICIPATION IN MUSIC AND PERFORMING ARTS. 2. TO ADVANCE THE EDUCATION OF THE PUPILS AT FROXFIELD PRIMARY SCHOOL BY PROVIDING AND ASSISTING IN THE PROVISION OF FACILITIES (NOT REQUIRED TO BE PROVIDED BY THE LOCAL EDUCATION AUTHORITY) FOR EDUCATION AT THE SCHOOL. NOTHING IN THIS CONSTITUTION SHALL AUTHORISE AN APPLICATION OF THE PROPERTY OF THE CIO FOR THE PURPOSES WHICH ARE NOT CHARITABLE IN ACCORDANCE WITH ENGLISH LAW.
