Objects: THE OBJECTS FOR WHICH THE CHARITY IS ESTABLISHED FOR THE PUBLIC BENEFIT ARE ("THE OBJECTS"):3.1.1 TO ADVANCE EDUCATION THROUGHOUT THE WORLD, PARTICULARLY (BUT NOT EXCLUSIVELY) AMONG CHILDREN AND YOUNG PERSONS, BY MEANS INCLUDING (BUT NOT LIMITED TO):(A) SUPPORTING THE DEVELOPMENT AND IMPROVEMENT OF EDUCATIONAL FACILITIES AND INFRASTRUCTURE;(B) SUPPORTING INCLUSIVE EDUCATION FOR PERSONS WITH DISABILITIES;(C) SUPPORTING AND TRAINING TEACHERS AND CARERS, AND IMPROVING ACCESS TO QUALITY EDUCATION;3.1.2 TO PREVENT AND RELIEVE POVERTY, SUFFERING AND DISTRESS, AND TO PREVENT DISEASE AND ILL-HEALTH ANYWHERE IN THE WORLD, IN PARTICULAR (BUT NOT LIMITED TO) THE PROVISION OF, OR ASSISTING IN THE PROVISION OF:(A) PROJECTS THAT MEET THE NEEDS OF PERSONS WITH DISABILITIES; (B) PROJECTS RELATING TO HEALTHCARE, HYGIENE, FOOD RELIEF, AND ACCESS TO CLEAN WATER; (C) ADVOCACY FOR CHARITABLE BENEFICIARIES BY EDUCATING, ENGAGING WITH AND MOBILISING THE PUBLIC CONCERNING THE NATURE, CAUSES AND EFFECTS OF DISABILITY, POVERTY AND ILL-HEALTH;(D) EMERGENCY RELIEF THAT ASSISTS PEOPLE AFFECTED BY CONFLICT OR DISASTER;(E) ALL THE NECESSARY SUPPORT DESIGNED TO ENABLE INDIVIDUALS AND COMMUNITIES TO GENERATE A SUSTAINABLE INCOME AND BECOME SELF-SUFFICIENT;3.1.3 TO PROMOTE AND UPHOLD THE PRINCIPLES AND VALUES OF THE CHRISTIAN FAITH, INCLUDING (BUT NOT LIMITED TO) WORKING WITH AND STRENGTHENING THE WORK OF CHRISTIAN CHURCHES AND CHRISTIAN UNIONS IN ANY PART OF THE WORLD IN PROVIDING SERVICES, RESOURCES AND MATERIALS TO COMMUNITIES OR SCHOOLS, INCLUDING (BUT NOT LIMITED TO) THOSE AFFECTED BY DISABILITIES, CONFLICT, DISASTERS, AND POVERTY, REGARDLESS OF RACE, NATIONALITY, RELIGION, GENDER, OR POLITICAL AFFILIATION.3.1.4 TO FULFIL SUCH OTHER PURPOSES WHICH ARE EXCLUSIVELY CHARITABLE ACCORDING TO THE LAW OF ENGLAND AND WALES AND ARE CONNECTED WITH THE ABOVE CHARITABLE WORK OF THE CHARITY.
