PROVIDING PLACES OF WORSHIP AND HOLDING REGULAR CHRISTIAN SERVICES INCLUDING SUNDAY SERVICES, MIDWEEK BIBLE STUDIES/SERVICES, PRAYER MEETINGS, REVIVAL GATHERINGS, CONFERENCES, AND OTHER CHRISTIAN ASSEMBLIES. 2. PROMOTING AND RAISING AWARENESS OF THE CHRISTIAN FAITH THROUGH DISCIPLESHIP PROGRAMMES, TEACHING, LEADERSHIP DEVELOPMENT, SPIRITUAL TRAINING, AND STRUCTURED COURSES SUCH AS THE BELIEVERS CLASS, WORKERS-IN-TRAINING PROGRAMME, AND LEADERSHIP COURSES 3. CARRYING OUT CHRISTIAN DEVOTIONAL PRACTICES INCLUDING PRAYER, INTERCESSION, WORSHIP, FASTING, ALTAR MINISTRY, AND SPIRITUAL RETREATS. 4. CONDUCTING EVANGELISM, MISSIONARY WORK, AND COMMUNITY OUTREACH, INCLUDING STREET EVANGELISM, MISSIONS, DISCIPLESHIP FOLLOW-UP, AND PUBLIC PREACHING EVENTS. 5. PROVIDING RELIEF AND ASSISTANCE TO INDIVIDUALS IN NEED THROUGH WELFARE SUPPORT, FOOD DISTRIBUTION, PASTORAL CARE, COUNSELLING, VISITATIONS, AND COMMUNITY RELIEF PROJECTS. 6. PROMOTING MORAL, SPIRITUAL, AND PERSONAL DEVELOPMENT OF CHILDREN, YOUNG PEOPLE, MEN, WOMEN, FAMILIES, AND OTHER GROUPS THROUGH AGE-SPECIFIC CHRISTIAN MINISTRIES AND PROGRAMMES. THESE OBJECTS FALL WITHIN THE LEGAL CHARITABLE PURPOSE OF THE ADVANCEMENT OF RELIGION, AND WHERE APPLICABLE, THE RELIEF OF THOSE IN NEED.
