TO ADVANCE ANY OTHER EXCLUSIVELY CHARITABLE PURPOSE FOR THE PUBLIC BENEFIT AS THE TRUSTEES MAY FROM TIME TO TIME DETERMINE, PROVIDED THAT SUCH PURPOSES ARE RECOGNISED AS CHARITABLE UNDER THE LAWS OF ENGLAND AND WALES AND SATISFY THE PUBLIC BENEFIT REQUIREMENT SET OUT IN THE CHARITIES ACT 2011.3.1.3. NOTHING IN THIS CONSTITUTION SHALL AUTHORISE AN APPLICATION OF THE PROPERTY OF THE CIO FOR PURPOSES WHICH ARE NOT CHARITABLE IN ACCORDANCE WITH SECTION 7 OF THE CHARITIES AND TRUSTEE INVESTMENT (SCOTLAND) ACT 2005 AND SECTION 2 OF THE CHARITIES ACT (NORTHERN IRELAND) 2008.
