Objects: 3.1 THE OBJECTS OF THE CIO ARE TO APPLY SUCH MONEY IT SHALL FROM TIME TO TIME THINK FIT: - A. IN MAKING PAYMENTS TO QUALIFYING SCHOOLS FOR THE ADVANCEMENT OF EDUCATION OF BENEFICIARIES. B. IN AWARDING SCHOLARSHIPS TO BENEFICIARIES FOR PAYMENT OF FEES AND EXPENSES AT ANY TRAINING COLLEGE FOR TEACHERS, UNIVERSITY OR OTHER INSTITUTION OF FURTHER (INCLUDING PROFESSIONAL AND TECHNICAL)"EDUCATION APPROVED BY THE CHARITY TRUSTEES TO BE AWARDED UNDER RULES TO BE MADE BY THE CHARITY TRUSTEES, INCLUDING RULES AS TO THE VALUE AND PERIOD OF TENURE OF THE EXHIBITIONS AND THE QUALIFICATIONS AND METHOD OF ASCERTAINMENT AND SELECTION OF CANDIDATES. C. D. IN OTHERWISE PROMOTING THE EDUCATION (INCLUDING EDUCATIONAL ENRICHMENT) OF BENEFICIARIES. 3.2. IN THIS PARAGRAPH:- A. "QUALIFYING SCHOOLS" MEANS STATE FUNDED SCHOOLS AND ACADEMIES WITHIN THE FORMER METROPOLITAN BOROUGH OF FULHAM IN WHICH RELIGIOUS INSTRUCTION IS GIVEN IN ACCORDANCE WITH THE DOCTRINES OF CHRISTIANITY.B.
