**Activities:** The Charity has been set up to support the design and construction of a safe , multi user trail from Dartington to Buckfastleigh, passing through Dartington Estate , ancient woodland , along quiet lanes, across farmland , over medieval bridges to this gateway town to Dartmoor, It will be open to all and connect up National Cycle Routes. Once built the route will be maintained by volunteers.
