L-196416).

**Activities:** Animal Wellness Trust UK delivers structured animal welfare programmes in Sri Lanka, including rescue and rehabilitation, veterinary care, sterilisation initiatives, education on responsible pet ownership, and capacity-building for local professionals. The charity also supports rehoming and works collaboratively to improve long-term animal welfare standards.
