**Objects:** THE OBJECTS OF THE CIO ARE TO PROMOTE EQUALITY AND DIVERSITY IN THE UK SPORTS MEDIA INDUSTRY BY: I. ORGANISING A SERIES OF DEVELOPMENT SESSIONS WHERE YOUNG, DIVERSE INDIVIDUALS ARE PROVIDED WITH VALUABLE INSIGHTS, SKILLS, AND KNOWLEDGE RELATED TO THE SPORTS MEDIA INDUSTRY; II. OFFERING PARTICIPANTS A CLEAR UNDERSTANDING OF THE VARIOUS PATHWAYS AVAILABLE WITHIN THE SPORTS MEDIA INDUSTRY, TO HELP DEMYSTIFY THE INDUSTRY AND EQUIP PARTICIPANTS WITH THE INFORMATION THEY NEED TO NAVIGATE THEIR CAREERS EFFECTIVELY; III. ACTIVELY CREATING OPPORTUNITIES FOR PARTICIPANTS TO GAIN PRACTICAL EXPERIENCE IN THE INDUSTRY, PROVIDING HANDS-ON EXPOSURE FOR BUILDING CONFIDENCE, HONING SKILLS, AND GAINING A DEEPER UNDERSTANDING OF THE FIELD; IV. EMPHASISING NETWORKING, TO GIVE PARTICIPANTS THE CHANCE TO CONNECT WITH INDUSTRY PROFESSIONALS WHICH CAN LEAD TO MENTORSHIP, JOB OPPORTUNITIES, AND COLLABORATIONS; AND V. COLLABORATING WITH INDUSTRY GIANTS, WITH SUCH PARTNERSHIPS PROVIDING RESOURCES, EXPERTISE AND SUPPORT, TO ENHANCE THE IMPACT OF THE CIO'S INITIATIVES.
