Objects: 3.1 THE OBJECTS OF THE CIO ARE, FOR THE PUBLIC BENEFIT, TO ADVANCE SUCH CHARITABLE PURPOSES (ACCORDING TO THE LAW OF ENGLAND AND WALES) AS THE CHARITY TRUSTEES SEE FIT FROM TIME TO TIME AND IN PARTICULAR, BUT NOT LIMITED TO:3.1.1 THE PROMOTION OF PHYSICAL HEALTH AND MENTAL WELLBEING THROUGH PROMOTING COMMUNITY PARTICIPATION IN HEALTHY RECREATIONAL ACTIVITIES INCLUDING PHYSICAL ACTIVITY AND SPORT;3.1.2 THE FACILITATION OF EDUCATIONAL AND LEISURE TIME ACTIVITIES PARTICULARLY BUT NOT EXCLUSIVELY FOR YOUNG PEOPLE TO ENABLE THEM TO DEVELOP SKILLS AND CAPABILITIES TO ENHANCE THEIR EMPLOYABILITY AND ENABLE THEM TO LIVE HEALTHY AND ACTIVE LIVES;3.1.3 THE PROMOTION OF SOCIAL INCLUSION BY PREVENTING PEOPLE FROM BECOMING SOCIALLY EXCLUDED AND RELIEVING THE NEEDS OF THOSE PEOPLE WHO ARE SOCIALLY EXCLUDED AND ASSISTING THEM TO INTEGRATE INTO SOCIETY. FOR THE PURPOSE OF THIS CLAUSE ?SOCIALLY EXCLUDED? MEANS BEING EXCLUDED FROM SOCIETY, OR PARTS OF SOCIETY, AS A RESULT OF ONE OR MORE OF THE FOLLOWING FACTORS: UNEMPLOYMENT; FINANCIAL HARDSHIP; YOUTH OR OLD AGE; ILL HEALTH (PHYSICAL OR MENTAL); SUBSTANCE ABUSE OR DEPENDENCY INCLUDING ALCOHOL AND DRUGS; DISCRIMINATION ON THE GROUNDS OF SEX, RACE, DISABILITY, ETHNIC ORIGIN, RELIGION, BELIEF, CREED, SEXUAL ORIENTATION OR GENDER REASSIGNMENT; POOR EDUCATIONAL OR SKILLS ATTAINMENT; RELATIONSHIP AND FAMILY BREAKDOWN; POOR HOUSING (THAT IS HOUSING THAT DOES NOT MEET BASIC HABITABLE STANDARDS; CRIME (EITHER AS A VICTIM OF CRIME OR AS AN OFFENDER REHABILITATING INTO SOCIETY).
