TO PROMOTE THE SOUND ADMINISTRATION OF THE LAW FOR THE PUBLIC BENEFIT, PARTICULARLY BY:• PROVIDING FREE, IMPARTIAL LEGAL INFORMATION AND PROCEDURAL GUIDANCE TO INDIVIDUALS INVOLVED IN LEGAL PROCEEDINGS, TO HELP THEM UNDERSTAND COURT PROCESSES, CORRESPONDENCE AND REQUIREMENTS, WITHOUT OFFERING LEGAL ADVICE OR REPRESENTATION;• IMPROVING UNDERSTANDING OF HOW COURT AND TRIBUNAL SYSTEMS OPERATE IN PRACTICE, INCLUDING THROUGH EVIDENCE-BASED RESEARCH AND EDUCATIONAL ACTIVITY THAT IDENTIFIES STRENGTHS AND WEAKNESSES IN LEGAL PROCESSES AND ADMINISTRATION IN THE COURT SYSTEM;
