**Objects:** TO CONSERVE AND PROTECT THE ENDANGERED NATIVE RED SQUIRREL, AND TO PROMOTE THE PROTECTION AND IMPROVEMENT OF THE PHYSICAL AND NATURAL ENVIRONMENT ON WHICH IT DEPENDS, FOR THE PUBLIC BENEFIT, BY: A) EDUCATING THE PUBLIC ABOUT RED SQUIRREL CONSERVATION AND THE IMPORTANCE OF PROTECTING AND ENHANCING THE HABITATS THAT SUPPORT THIS NATIVE SPECIES;B) PROMOTING AND FACILITATING COMMUNITY ENGAGEMENT IN WILDLIFE CONSERVATION, PARTICULARLY ACROSS THE NORTH EAST OF ENGLAND AND WITH A SPECIFIC FOCUS ON THE COMMUNITY OF SOUTH EAST NORTHUMBERLAND, TO HELP PEOPLE BETTER UNDERSTAND, VALUE AND ENJOY RED SQUIRRELS AND OTHER FLORA AND FAUNA WITHIN LOCAL GREEN SPACES AND WOODLANDS; AND C) ASSISTING, COMMISSIONING AND CONDUCTING RESEARCH CONNECTED TO THE CONSERVATION OF RED SQUIRRELS, AND DISSEMINATING THE RESULTS WHERE APPROPRIATE, TO IMPROVE CONSERVATION PRACTICE AND HELP ENSURE THE SPECIES IS PROTECTED FOR FUTURE GENERATIONS.
