B) DELIVERING HEALTH EDUCATION WORKSHOPS AND TRAINING FOR THE PUBLIC, DESIGNED TO INCREASE KNOWLEDGE AND SKILLS TO IMPROVE HEALTH AND PREVENT ILLNESS. C) WORKING WITH LOCAL HEALTH PROVIDERS, SCHOOLS, AND COMMUNITY ORGANISATIONS TO IMPROVE ACCESS TO PREVENTATIVE HEALTH INFORMATION AND SERVICES.
