Objects: 3.1 THE OBJECTS OF THE CIO, FOR THE PUBLIC BENEFIT, TO BE UNDERTAKEN FOR THE BENEFIT OF THE INHABITANTS OF FAVERSHAM AND THE SURROUNDING AREA (THE 'AREA'), BY MAKING GRANTS TO CHARITIES, GROUPS AND INDIVIDUALS, ARE: 3.1.1 TO ADVANCE THE EDUCATION OF THE PUBLIC IN GENERAL;3.1.2 THE PROTECTION AND PROMOTION OF BOTH MENTAL AND PHYSICAL HEALTH;3.1.3 THE RELIEF OF POVERTY AND SICKNESS;3.1.4 THE PROMOTION OF PUBLIC APPRECIATION IN THE ARTS;3.1.5 THE PROMOTION OF EQUALITY AND DIVERSITY, AND THE PROMOTION OF RACIAL AND/OR RELIGIOUS HARMONY3.1.6 THE CONSERVATION, PROTECTION AND IMPROVEMENT OF THE PHYSICAL AND NATURAL OF THE ENVIRONMENT;3.1.7 TO RELIEVE THE SUFFERING OF ANIMALS IN NEED OF CARE AND ATTENTION AND TO PROMOTE HUMANE BEHAVIOUR TOWARDS ANIMALS AND TO EDUCATE THE PUBLIC IN MATTERS PERTAINING TO ANIMAL WELFARE IN GENERAL AND THE PREVENTION OF CRUELTY AND SUFFERING AMONG ANIMALS;3.1.8 THE PROMOTION OF COMMUNITY PARTICIPATION IN HEALTHY RECREATION; AND3.1.9 TO DEVELOP THE CAPACITY AND SKILLS OF MEMBERS WHO ARE PART OF A SOCIALLY AND ECONOMICALLY DISADVANTAGED COMMUNITY WITHIN THE AREA IN SUCH A WAY THAT THEY ARE BETTER ABLE TO IDENTIFY, AND HELP MEET, THEIR NEEDS AND TO PARTICIPATE MORE FULLY IN SOCIETY;3.1.10 AND SUCH OTHER EXCLUSIVELY CHARITABLE PURPOSES WHICH ARE IN THE OPINION OF THE TRUSTEES BENEFICIAL TO THE COMMUNITY AND FOR THE PUBLIC BENEFIT IN THE AREA.
