Objects: THE OBJECTS OF THE CIO ARE: TO ADVANCE EDUCATION, IN PARTICULAR BUT NOT EXCLUSIVELY JEWISH EDUCATION, PRINCIPALLY BUT NOT EXCLUSIVELY IN THE UNITED KINGDOM, BY MAKING GRANTS TO CHARITIES OR OTHER ORGANISATIONS THAT PROVIDE EDUCATION AND BY AWARDING SCHOLARSHIPS TO INDIVIDUALS THE PREVENTION OR RELIEF OF POVERTY OR FINANCIAL HARDSHIP, PRINCIPALLY BUT NOT EXCLUSIVELY IN THE UNITED KINGDOM, IN PARTICULAR BUT NOT EXCLUSIVELY BY MAKING GRANTS TO CHARITIES OR OTHER ORGANISATIONS WORKING TO PREVENT OR RELIEVE POVERTY OR FINANCIAL HARDSHIP, TO ADVANCE THE ORTHODOX JEWISH RELIGION, PRINCIPALLY BUT NOT EXCLUSIVELY IN THE UNITED KINGDOM, IN ACCORDANCE WITH THE PRINCIPLES OF THE CODE OF JEWISH LAW (SHULCHAN ARUCH), IN PARTICULAR, BUT NOT EXCLUSIVELY, BY MAKING GRANTS TO SYNAGOGUES OR OTHER RELIGIOUS ORGANISATIONS, AND BY MAKING GRANTS FOR RELIGIOUS CEREMONIES, AND FOR RELIGIOUS OR DEVOTIONAL ARTEFACTS AND ITEMS USED IN RELIGIOUS SERVICES, RITUALS OR PRACTICES THE RELIEF OF SICKNESS AND THE PRESERVATION OF HEALTH, PRINCIPALLY BUT NOT EXCLUSIVELY IN THE UNITED KINGDOM, IN PARTICULAR BUT NOT EXCLUSIVELY BY MAKING GRANTS TO CHARITIES AND OTHER ORGANISATIONS WORKING TO RELIEVE SICKNESS AND PRESERVE HEALTH TO ADVANCE IN LIFE AND RELIEVE THE NEEDS OF YOUNG PEOPLE, PRINCIPALLY BUT NOT EXCLUSIVELY IN THE UNITED KINGDOM, BY MAKING GRANTS TO CHARITIES OR OTHER ORGANISATIONS THAT HELP YOUNG PEOPLE THROUGH (A) THE PROVISION OF RECREATIONAL AND LEISURE TIME ACTIVITIES PROVIDED IN THE INTEREST OF SOCIAL WELFARE, DESIGNED TO IMPROVE THEIR CONDITIONS OF LIFE; (B) PROVIDING SUPPORT AND ACTIVITIES WHICH DEVELOP THEIR SKILLS, CAPACITIES AND CAPABILITIES TO ENABLE THEM TO PARTICIPATE IN SOCIETY AS MATURE AND RESPONSIBLE INDIVIDUALS.
