The trustees present their report and accounts for the year ended 30 June 2025.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the trust's deed of trust, applicable law and the requirements of the Statement of Recommended Practice and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Administrative Details of the Charity, its Trustees and Advisers

The trustees throughout the year were M Atkinson CMG MBE, R Jude PhD, I C Sargeant FCA, B. Thomas, M J Nicholls ACIB BSc and F P Whitlock BEng MBA.

The charity does not have a principal office. Correspondence regarding the charity should be addressed to The Honorary Treasurer, Mr I. C. Sargeant, The Spinney, Farnham Road, Ewshot, Farnham, Surrey GU10 5AU.

There is no chief executive officer for the charity. The honorary treasurer is responsible for accounting for monies received and expended.

Details of the charity's bankers and of its independent examiner are set out on page 1. There are no solicitors or financial advisers appointed by the charity.

Structure, Governance and Management

The charity was established by a deed of trust which was signed on the 27 July 1961. Trustees are appointed by members of The Rotary Club of Farnham by resolution. It is a requirement for a trustee to be a member of the Rotary Club of Farnham. Being a small charity there are no written procedures for appointing trustees. Members would be sounded out regarding willingness to act as a trustee. When a person agreed to be a trustee this would be considered by the club council and recommended to members for approval by resolution. No other body can appoint a trustee.

Trustees may already be trustees of another charity and need no further training. The club has people who are trustees of another charity. Any guidance necessary for a new trustee to carry out his/her duties would be given by the existing trustees. The new trustee would be given a copy of "The Essential Trustee – What you need to know" published by The Charity Commission.

As the charity has no staff no decision making is delegated.

Trustees may be removed by resolution of the club for any reason which may appear to the club to be sufficient and without assigning any reason and whereupon the trustee so removed shall for the purpose of the exercise of the statutory power of appointing new trustees be deemed to be dead.

In the event of the club being dissolved or discontinued or of the club resolving to discontinue the Benevolent Fund the trustees shall hold the Benevolent Fund upon trust to transfer the same and for the augmentation of the charity fund of any other Rotary Club being a fund established solely for purposes which are charitable at law or to any charitable institution and/or pay and distribute or otherwise deal with the same to and for the benefit of such other charitable funds as the club shall direct.

Decisions on the amount and who should be given donations from the charity's fund are made by the members of The Rotary Club of Farnham by simple majority in a formal business meeting. Trustees sign the cheques or initiate bank transfers after approval.

The charity is affiliated with Rotary in GB and Ireland (RGI) and Rotary International, including The Rotary Foundation, which is an international charity supporting world wide schemes for the benefit of people in need.

The club may from time to time agree with The Rotary Club of Farnham Weyside to jointly raise funds for an agreed project objective and/or charity. It may also agree with another RGI Club or overseas club to achieve an agreed objective.

The trustees have not identified any major risks to which the charity could be exposed. The accounts of The Benevolent Fund are examined annually by an independent examiner. The bank account is separate from those of The Rotary Club of Farnham.

Objectives and Activities

The trustees may apply the income of The Benevolent Fund to or for the relief of persons financially distressed and to or for the benefit of such charitable institutions societies and objects as the club shall from time to time direct. Details of the achieved objectives for the year are set out below under the heading Achievements and Performance.

No financial objectives are set for the charity. There is no subsidiary undertaking of the charity.

The president of The Rotary Club of Farnham may nominate charities for fund raising during his/her term of office. Suggestions to award other grants are made by members of the club. This may be as a result of a request from a person for a specific objective. Agreed requests are submitted to the club Council, and if the Council agrees, put to the members and accepted or rejected by majority vote at a business meeting. After the collection dates have been booked with the local authority, decisions are made for the allocation of funds from street collections to charities by the club.

Achievements and Performance

During the 12 month period ended 30 June 2025, the Club has raised a gross amount of over £26,377 (versus £25,688 in the previous year) by fund-raising activities and voluntary donations from members. Over £13,000 has been distributed to 15 charitable causes. The cost of fundraising in the year rose from £7100, to £7,558.

The charities that were sent grants by the fund included Kids for Kids, Malawi Schools Trust, Helen Arkell Dyslexia Centre, End Polio Now, Rotary Foundation UK, and several local charities (see Note 3 in the accounts).

The amount of £5000 has been raised and is being held for transfer to the Cut Out Cancer appeal initiated amongst other local Rotary Clubs to assist the Royal Surrey County Hospital, awaiting confirmation of a RI grant.

The club also raised and is holding, at the date of the balance sheet, £2392 towards the global grant to be awarded towards the cost of extending and upgrading the Phyllis Tuckwell Hospice.

The club supported a Golf Day in September 2024 for the Phyllis Tuckwell Hospice and raised £1262 by holding a raffle and donating a prize to the auction (donations by participants were paid directly to the charity concerned and do not therefore appear in these accounts).

A Bridge Lunch was held during the year raising over £1200.

With the club raffle and auction during a Club Golf Day in June 2025 raising approximately £5300, total charitable donations made by the club during the year through the Rotary Club of Farnham Benevolent Fund were therefore in excess of £13,000 (PY £12,000). The trustees consider that, following the disruptive years of the pandemic and a fall in club membership, a recent increase in fund-raising is encouraging and should lead to an increase in charitable giving.

Financial Review

The accounts are set out on pages 7-9. The activities for generating funds are set out on page 9 of these accounts. Income is raised by members of The Rotary Club of Farnham and a few unpaid volunteers. Details of grants awarded are set out on page 9 of the accounts.

The revenues are used to meet the needs of whomever or whatever is deemed necessary by the members of The Rotary Club of Farnham and the trustees from time to time. There is no deficit in the fund. The charity is content with low bank balances in the knowledge that funds raised have been distributed in accordance with the wishes of the trustees, members of The Rotary Club of Farnham and in accordance with the trust deed.

The charity's policy is to hold sufficient reserves to ensure that it has enough resources to fund its activities.

The charity does not hold any investments or own any property. The charity has no employees.

Plans for Future Periods

Fund-raising events are continually under review. The club will continue to support the Phyllis Tuckwell Hospice with their Golf Day raffle and Christmas Street Collections will continue to take place.

In addition, the Club will carry on raising funds in various ways for the benefit of deserving causes locally and overseas.



During the 12 month period ended 30 June 2024, the Club has raised over £25,688 (versus £17,765 in the previous year) by fund-raising activities and voluntary donations from members. £15,000 has been distributed to 23 charitable causes. The cost of fundraising in the year rose from £2,699 to £7,100 due to the type of events held.

The charities that were sent grants by the fund included Disability Challengers, Space2Grow, Kids Out, Seeds for Development, End Polio Now, Rotary Foundation UK, and several local charities.

In addition, the club supported a Golf Day in September 2023 for the Phyllis Tuckwell Hospice and raised £1262 by holding a raffle and donating a prize to the auction (donations by participants were paid directly to the charity concerned and do not therefore appear in these accounts). A Bridge Lunch was held during the year raising over £1600.

With the club raffle and auction during the Golf Day raising approximately £1262, total charitable donations by the club through the Rotary Club of Farnham Benevolent Fund were therefore in excess of £12,000 (PY £16200). The trustees present their report and accounts for the year ended 30 June 2022.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the trust's deed of trust, applicable law and the requirements of the Statement of Recommended Practice and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Administrative Details of the Charity, its Trustees and Advisers

The trustees throughout the year were M Atkinson CMG MBE, D. Coker FCIS, R Jude PhD, I C Sargeant FCA and B. Thomas. Sadly, David Coker FCIS died on 8 August 2022.

The charity does not have a principal office. Correspondence regarding the charity should be addressed to The Honorary Treasurer, Mr I. C. Sargeant, The Spinney, Farnham Road, Ewshot, Farnham, Surrey GU10 5AU.

There is no chief executive officer for the charity. The honorary treasurer is responsible for accounting for monies received and expended.

Details of the charity's bankers and of its independent examiner are set out on page 1. There are no solicitors or financial advisers appointed by the charity.

Structure, Governance and Management

The charity was established by a deed of trust which was signed on the 27 July 1961. Trustees are appointed by members of The Rotary Club of Farnham by resolution. It is a requirement for a trustee to be a member of the Rotary Club of Farnham. Being a small charity there are no written procedures for appointing trustees. Members would be sounded out regarding willingness to act as a trustee. When a person agreed to be a trustee this would be considered by the club council and recommended to members for approval by resolution. No other body can appoint a trustee.

Trustees may already be trustees of another charity and need no further training. The club has several people who are trustees of another charity. Any guidance necessary for a new trustee to carry out his/her duties would be given by the existing trustees. The new trustee would be given a copy of "The Essential Trustee – What you need to know" published by The Charity Commission.

As the charity has no staff no decision making is delegated.

Trustees may be removed by resolution of the club for any reason which may appear to the club to be sufficient and without assigning any reason and whereupon the trustee so removed shall for the purpose of the exercise of the statutory power of appointing new trustees be deemed to be dead.

In the event of the club being dissolved or discontinued or of the club resolving to discontinue The Benevolent Fund the trustees shall hold the Benevolent Fund upon trust to transfer the same and for the augmentation of the charity fund of any other Rotary Club being a fund established solely for purposes which are charitable at law or to any charitable institution and/or pay and distribute or otherwise deal with the same to and for the benefit of such other charitable funds as the club shall direct.

Decisions on the amount and who should be given donations from the charity's fund are made by the members of The Rotary Club of Farnham by simple majority in a formal business meeting. Trustees sign the cheques or initiate bank transfers after approval.

The charity is affiliated with Rotary in GB and Ireland (RGI) and Rotary International, including The Rotary Foundation, which is an international charity supporting world wide schemes for the benefit of people in need.

The club may from time to time agree with The Rotary Club of Farnham Weyside and The Inner Wheel Club of Farnham or both to jointly raise funds for an agreed project objective and/or charity, but it should here be noted that the Inner Wheel Club of Farnham was wound up on 30 June 2022. It may also agree with another RGI Club or overseas club to achieve an agreed objective.

The trustees have not identified any major risks to which the charity could be exposed. The accounts of The Benevolent Fund are examined annually by an independent examiner. The bank account is separate from those of The Rotary Club of Farnham.

Objectives and Activities

The trustees may apply the income of The Benevolent Fund to or for the relief of persons financially distressed and to or for the benefit of such charitable institutions societies and objects as the club shall from time to time direct. Details of the achieved objectives for the year are set out below under the heading Achievements and Performance.

No financial objectives are set for the charity. There is no subsidiary undertaking of the charity.

The president of The Rotary Club of Farnham may nominate charities for fund raising during his/her term of office. Suggestions to award other grants are made by members of the club. This may be as a result of a request from a person for a specific objective. Agreed requests are submitted to the club Council, and if the Council agrees, put to the members and accepted or rejected by majority vote at a business meeting. After the collection dates have been booked with the local authority, decisions are made for the allocation of funds from street collections to charities by the club.

Achievements and Performance

During the 12 month period ended 30 June 2022, the Club has raised over £33,000 (versus £15,000 in the previous year) by fund-raising activities and voluntary donations from members. £28,000 has been distributed to 26 charitable causes.

The increase was a result of a large rise in donations from members to the charity. This arose from the closure of the lunch accounts which resulted in several members asking for their credit balances to be transferred to the charity. The charities that were sent grants by the fund included the Ukraine Appeal, Action for Carers in Surrey, Helen Arkell Dyslexia Charity, Afghanistan Appeal, End Polio Now, Rotary Foundation UK, and many local charities.

In addition, the club held a Golf Day which raised a net amount of £8793 (PY £4919) for the Phyllis Tuckwell Hospice (donations by participants were paid directly to the charity concerned and do not therefore appear in these accounts).

The annual Cyclathon event was again suspended during this year to enable the club to focus on a special fund-raising dance and charity auction, originally planned for May 2020. Due to the Covid-19 pandemic this event was again postponed but eventually took place on 16th September 2021, which boosted the fund raising of the year by over £5000.

Total charitable donations by the club through the Rotary Club of Farnham Benevolent Fund and by the club's charitable activities were therefore in **excess of £37,000** (previous year £20,000). The trustees consider that, given the continuing problems arising from the pandemic and increasing lunch costs that have reduced the members' lunch attendances, the performance of the club in raising funds during the year has been very good.
