During the year the trust invested the majority of the proceeds from the sale of land to Carla Homes with Manor Bridge Investments.

Dividend income from investments was £30,518 and interest of £1,009 was also received.

The trustees agreed a donation to St Mary the Virgin of £5,000 during the year to 31 December 2020.

Since the end of the year the trustees have arranged for a new drainage system at St Marys and have agreed to support the PCC in making all the necessary repairs to the fabric of the church listed in the latest quinquennial report. Donations amounting to a sum in excess of £150,000 to cover the costs of this work are proposed by the trustees as and when faculties can be obtained.

The trustees have also supported the village croquet tournament and will be hoping to support other events in 2021.

## **Independent Examiner's Report to the Drayton Beauchamp Parochial Charity**
