THE DISPOSAL OF THE READING ROOM REPRESENTED THE LOSS OF A PUBLIC FACILITY IN SHUTLANGER.

THE TRUSTEES' INTENTION IS TO MAKE A DISCRETIONARY GRANT TO ASSIST WITH THE UPKEEP AND REPAIR OF SHUTLANGER VILLAGE HALL WHICH IS A PUBLIC FACILITY.
