(2) THE TRUSTEES MAY PAY FOR SUCH ITEMS, SERVICES OR FACILITIES BY WAY OF DONATIONS OR SUBSCRIPTIONS TO INSTITUTIONS OR ORGANISATIONS WHICH PROVIDE OR UNDERTAKE TO PROVIDE SUCH ITEMS SERVICES OR FACILITIES FOR SUCH PERSONS (3) IN EXCEPTIONAL CASES THE TRUSTEES MY GRANT RELIEF TO PERSONS OTHERWISE ELIGIBLE THERFOR WHO ARE RESIDENT IMMEDIATELY OUTSIDE THE SAID PARISH BUT IN THE OPINION OF THE TRUSTEES AND NEVERTHELESS FOR SUFFICIENT REASON TO BE TREATED AS IF RESIDENT THEREIN OR WHO ARE LOCATED FOR THE TIME BEING WITHIN THAT PARISH.
