Activities

Objects: (1) TO FURTHER THE RELIGIOUS AND OTHER CHARITABLE WORK OF THE CHURCH OF ENGLAND IN THE PARISH BY MAINTAINING AND REPAIRING THE FABRIC OF THE CHURCH AT FELSHAM ST PETERS; (2) THE RELIEF OF PERSONS RESIDENT IN THE AREA OF BENEFIT WHO ARE IN NEED, HARDSHIP OR DISTRESS. IN EXCEPTIONAL CASES THE TRUSTEES MAY DECIDE TO ASSIST SOMEONE (WHO IS OTHERWISE QUALIFIED) WHO IS RESIDENT OUTSIDE THE AREA OF BENEFIT OR ONLY TEMPORARILY RESIDENT IN THE AREA OF BENEFIT; (3) IN THE INTERESTS OF SOCIAL WELFARE TO IMPROVE THE GENERAL CONDITIONS OF LIFE OF THE INHABITANTS OF THE AREA OF BENEFIT; (4) SUCH CHARITABLE PURPOSES FOR THE BENEFIT OF THE RESIDENTS AS THE TRUSTEES DECIDE

Activities: The charity is divided into three branches: The general charity contributes exclusively to the benefit of the inhabitants of Felsham. The church charity contributes exclusively to the repair and maintenance of St Peter's Church, Felsham. The bread charity benefits the poor and necessitous people of Felsham according to circumstances.
