SECTION B: STRUCTURE GOVERNANCE AND MANAGEMENT

The Charity is governed by the OBJECTS AND RULES OF THE LEAGUE OF FRIENDS
OF EDGWARE GENERAL HOSPITAL dated 26 January 1984 Revised October 1998

The League of Friends is the Association constituted by the rules of the above.

Charity Trustees are elected from the membership.

SECTION C: OBJECTIVES AND ACTIVITIES

The objective of the League of Friends is to relieve patients and former patients of Edgware Community Hospital and other invalids in the community who are sick, convalescent, disabled, handicapped, infirm or in need of financial assistance and, generally, to support the charitable work of the said Hospital.

Since the League of Friends was formed in 1956 many hundreds of thousands of pounds has been provided to fund amenities, and of more recent times, medical equipment for the Hospital. The procedure for this has been by way of application from the relevant Ward, Clinic or Department for scrutiny and approval by the Trustees. Since the change from Edgware General Hospital to a Community Hospital this has become a great problem with different NHS Trusts having different, or lack of, financial procedures resulting in the League of Friends not financing items that they would be prepared so to do.

Over recent years membership of the League of Friends dwindled and at an Annual General Meeting in 2009 a resolution was passed to dissolve the League of Friends. This has proved to be a difficult task as a large sum of money is held in Bank Accounts and an Investment Portfolio and there have been very few items requested and funded within the Hospital due to lack of satisfactory documentary financial evidence provided by the various NHS Trusts.

SECTION D: ACHIEVEMENTS AND PERFORMANCE

This has been a challenging year due Covid 19 and how it has impacted the Hospital, the community and the Trustees. In essence there have been even fewer applications for funding from within the Hospital and we have had limited access to our Office or the Hospital. Donations to the Hospital were therefore limited to a small flourish at the end of the year.

Efforts will continue to dispose of funds appropriately in accordance with the Objects and Rules of the League of Friends.

SECTION E: FINANCIAL REVIEW

The Charity holds £110,273.76 in Bank Accounts and £86,612.00 in an Investment Portfolio.

No fund raising activities have been held.

No restricted funds designated for specific use are maintained.

The Trustees do not have a reserves policy.

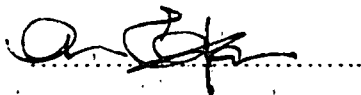

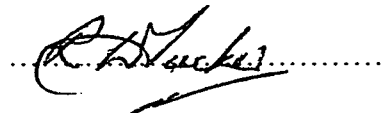

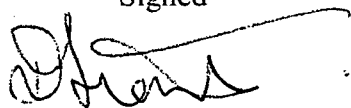
