Background

Objects

The income of the charity shall be applied for the benefit of the sick poor of the area of benefit as the Trustees think fit, such as:

- a) supply of bedding, comforts, food fuel or medical or other aids
- b) grants for convalescence, holidays or domestic help
- c) donations to the funds of institutions or organisations which give care or relief to the sick poor of the benefit area.

The Trustees are required to observe the following restrictions:

- a) they may not pay for relief of rates, taxes or other public funds;
- b) they may not commit themselves to making recurring grants;
- c) they may only assist individuals if satisfied that they are deserving and in need
- d) they may only apply income according to decisions of duly convened meetings.

Trustees

During the year one request for a grant was approved.

As at 30 November 2020, Hethersett aid in sickness has an accumulated surplus of £9,812 (£9,223 at 30 November 2019).
