(3) IN THE EVENT OF THE SAID OBJECT FAILING THE SAID LAND AND BUILDING SHALL BE HELD UPON TRUST FOR SOME ECCLESIASTICAL PURPOSE IN THE ECCLESIASTICAL PARISH OF NORTHAW.
