(B) FINANCIAL GRANTS FOR THE REPAIR, MAINTENANCE AND IMPROVEMENT OF THE FABRIC, BUILDING, ORNAMENTS EQUIPMENT AND AMENITIES OF THE SAID CHURCH, ALMSHOUSES AND BUILDINGS (C) TO RAISE FUNDS BY CHARITABLE MEANS FOR THE ADVANCEMENT OR BENEFIT AFORESAID OBJECTS OF THE HOSPITAL OR ITS INMATES.
