**REPORT OF THE TRUSTEES
for the Year Ended 30th June 2021**

The trustees present their report with the receipts and payments accounts of the charity for the year ended 30 June 2021.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governing document of the Lincolnshire Masonic Charity Association (LMCA) is a constitution dated 4 January 1963, amended on 9 September 1999 and 11 March 2010.
Details of the trustees who served during the year are set out on page 1.
The trustees are appointed by virtue of the office they hold within the Masonic Province of Lincolnshire.

OBJECTIVES AND ACTIVITIES

The objectives of the charity are to raise money for masonic charities. In order to do this each masonic lodge has a charity steward who collects donations from members and passes them on to the provincial charity steward who banks the money and records the donations.

ACHIEVEMENTS AND PERFORMANCE

The trustees consider the charity has had a good year. Donations collected have been donated to masonic charities, notably the Masonic Charitable Foundation.

The charity would not be able to provide such an efficient service if it were not for the continued voluntary help of the provincial charity steward.

FINANCIAL REVIEW

All funds received during the year have been distributed to their nominated charities after the year end. Overheads remain minimal.

INVESTMENT POWERS

The Trust Deed authorises the trustees to make and hold investments using the general funds of the charity but no such investments are presently held.

RISK POLICY

The trustees consider risk to be minimal and therefore currently have no specific policy. The trustees have agreed to continually monitor risk.

RESERVES POLICY

Reserves are generally kept to a minimum as the charity only acts as a collecting agency passing donations to their nominated charity each year. Unrestricted reserves will be used to cover management expenses and also further donations as agreed by the trustees.


PLANS FOR FUTURE PERIODS

The charity plans to continue to raise money for masonic charities.

PUBLIC BENEFIT REPORTING

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and planning future activities. All of the trustees give their time freely and no trustee remuneration was paid in the year.

PURPOSE OF RESTRICTED FUNDS

The purpose of the charity is to receive money for onward distribution to masonic charities on behalf of the individual lodges and their Brethren. The restriction on the funds is that the money must be donated to those charities for which the money has been received. The purpose for which the money must be used is therefore the responsibility of the individual rather than the LMCA. Masonic Charities include RMT for Girls & Boys, New Provincial Benevolent Fund and the Masonic Charitable Foundation.

Restricted funds are funds which have been donated or raised for charity by individual lodges. The restricted funds must be used wholly in respect of donations to masonic charities.

Unrestricted funds comprise those funds which the trustees are free to use in accordance with the charitable objects.
