TRUSTEES REPORT FOR YEAR ENDING 31ST MAY 2024

Chairperson's Report

In 1889 George Gibson began his teaching career in Coventry. He was given Standard IV, a class of boys many of whom were “wretchedly clothed, under nourished and almost bootless”. With the Head Teachers permission, George placed a “boot box” on his desk and invited visitors and better-off boys to contribute towards the purchase of boots – “in order that they might attend school”.

Four years later, at a local newspaper office, a meeting of well-known businessmen of the day decided to launch a city-wide fund involving all Coventry schools. Joseph Cash, William Hillman, John Gulson, Dr Webb-Folwer, Thomas Burbage, George Gibson and a police sergeant named Shelly attended the inaugural meeting.

Today in 2024, the Children's Boot Fund is still very much alive and kicking. After two World Wars and years of gloom followed by years of boom, thus unique Charity continues to provide footwear to children of poor families “in order that they may attend school”.

The fund has changed a little in its lifetime. The only real difference is perhaps the fact that a reputable Coventry supplier measures children for properly fitting shoes. Gone are the often-ill-fitting hob-nailed boots for boys and high lace up type for girls – all boots branded with an iron stamp to “prevent them going to places other than intended”. – a reference to the popular pawnshops of the day.

Today, the Management Committee are responsible for the application of vouchers, which when presented by the parent/guardian of the recipient at Charles Ager in Coventry, entitles the bearer to a pair of shoes suitable for school. Applications are made by parents/guardians, supported by Head Teachers, through all Coventry Schools, where forms are made available to all families. Applications are reviewed by the Trustees at four meeting each year and vouchers allocated on individual merit. The Fund has also been able to support refugee children in the current year and all appeals from refugees are dealt with immediately due to the urgent nature of their circumstances.

Fundraising has increased this year compared to 2023 and the Committee had established additional fundraising with the Charities Aid Fund who also administers our Gift Aid Scheme. There has been a significant demand for shoes this year, including supporting refugees, and it is expected to continue in the current economic climate. It is always difficult to strike balance between securing the future and meeting today's needs. However, the Trustees are aware that it is important to continue to raise funds as more families require help. The Trustees wish to thank everyone who has generously contributed to our funds during the past year as they are well aware of the financial constraints that we are all experiencing at this time.

Website developer company Noisegate Media has worked with Gail Downey for the Boot Fund at a non-profit, cost only basis, giving great value in helping to make the very generous funding provided by Clive Benfield extend much further to assist our visibility and fundraising.

However, the committee is still suffering from a shortage of members. We therefore ask again, that anyone in the education system willing to join a very dedicated children's Charity should get in touch with any of the Fund officials, who will then be happy to answer any questions and give an explanation of the workings of the Charity.

The Committees' thanks go to Charles Ager who have been particularly supportive and given excellent service to customers and good advice to the Committee.

Lastly, on behalf of the Committee of the Children's Boot Fund, I would like to take this opportunity to thank all other people who have raised funds in many different ways, often using a great deal of their own time and effort. Without your efforts, the Fund simply would not exist to help children in the Coventry area, and to lose the Fund after so many years of work would be a real tragedy, both now and in the future.

Treasurer's Report

On the 9th July 2024 Martin Harban who had been the Treasurer for the last 21 years sadly lost his courageous fight against Cancer. This Charity owes a huge debt of gratitude for all of his work not only dealing with the role of the Treasurer but also for his outstanding fundraising activities. If you will pardon the pun Martin's death has left large boots to fill and I am delighted to have been appointed as the Treasurer to this amazing Charity. It has been a steep learning curve having taken on the role just prior to the year end and I am grateful to the Board of Trustees for their support and encouragement and advice they have given to me in these early months of my tenure. I would also personally like to thank Martin's Secretary Valerie Tunnicliff for all of her work over the past decade and also Susan Wyllie in her capacity as Independent Examiner for her words of wisdom and guidance whilst I have been trying to prepare the accounts for the first time.

The Trustee's reserves policy will be to continue to maintain a level of reserves at about two and a half years funding because of the difficulty in predicting the level of donations from year to year. Currently the reserves are sufficient for approximately two years to meet the continuing expected high level of need and the increase in shoe costs. Trustees are actively looking at ways to fundraise. Without further additional donations the number of shoes provided will have to be reduced.

In previous years in the preparation of the accounts there has been a distribution of vouchers to the recipients following the Trustees Meeting in May. A number of these vouchers are utilised in June, July, August and even early September which coincides with the start of the new School Year. In the past the accounts have been prepared in early September and the exact numbers of vouchers being presented to the local school shoe firm Charles Ager's was not crystallised. This year due to the delay in the preparation of the annual accounts we have been able to use the exact figures for the vouchers being used and therefore for this year there has been a slight change in the accounting procedures.

The Trustees have acknowledged this and have agreed that in principle in future years we will continue to prepare the accounts towards the end of September/October when the number of vouchers utilised that have been distributed in the financial year ending the 31st May is known and that way we will presenting the accounts on a like for like basis going forward.


The Trustees wish to thank all supporting schools in the difficult economic climate, the generous gifts of the Barston Association, Provincial Grand Lodge of Warwickshire, Claverdon Fields Charitable Trust together with numerous Masonic Lodges, Coventry Church (Municipal) Charities and especially the Dame Alice Leigh Almshouse Charity, Tile Hill & Westwood Charities, Soothern & Craner and Newfield Charitable Trust who have been particularly generous in their donations to this Charity.

The Charity endeavours to hold as much cash as possible in an interest-bearing account. For this financial year the expenditure over income was £701.36 for the unrestricted funds and £1,327.67 for the restricted funds giving a total deficit of £2,029.03.

All administration and committee membership is voluntary and there are no employed members of the Charity. Administration costs are currently being met by the Tile Hill and Westwood Charities. Meetings are held by the kind permission of the Secretary at his home free of charge.

**INDEPENDENT EXAMINERS REPORT
TO THE TRUSTEES OF THE CHILDREN'S BOOT FUND**

I report on the accounts of the Charity for the year ended 31st May 2024, which are set out on the attached pages.

Respective responsibilities of Trustees and Examiner

As the Charity's Trustees you are responsible for the preparation of the accounts; you consider the audit requirement of S144(2) of the Charities Act 2011 (the 2011 Act) does not apply and that an independent examination is needed.

It is my responsibility to: examine the accounts under S145 of the 2011 Act; to follow the procedures laid down in the General Direction given by the Charity Commission under S145(5)(b) of the 2011 Act; and to state whether particular matters have come to my attention.

Basis of independent examiners report

My examination was carried out in accordance with the General Directions given by the Charity Commissioners.

An examination includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeking explanations from you as Trustees concerning any such matters.



NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MAY 2024

1. Accounting policies

The following accounting policies have been applied consistently in dealing with the items that are considered material in relation to the charity's financial statements.

- a. The financial statements are prepared under the historical cost convention as adjusted by the revaluation of investments. The accounts are in accordance with the Charities SORP 2005 (Accounting and Reporting by Charities) and comply with the Charities (Accounts and Reports) Regulations 2005 issued under the Charities Act 2011.
- b. The financial statements are prepared on an accruals basis.
- c. Investments are included in the balance sheet at market value.
- d. Legacies are accounted for when the charity has been notified before the end of the financial year and the value can be reasonably accurately determined.
- e. Donations are accounted for on a receipts basis.
- f. Expenditure relates to the purchase of children's shoes.

2. Management and administration of the charity

The administration costs of the Charity are currently being met by Tile Hill and Westwood Charities. All management costs are being met by The Boot Fund.
