**Objects:** 1) INCOME TO BE APPLIED IN RELIEVING EITHER GENERALLY OF INDIVIDUALLY A) PERSONS UNDER 21 YEARS OF AGE AND WHO ARE IN NEED OF FINANCIAL ASSISTANCE AND WHO ARE PREPARING FOR, ENTERING UPON OR ENGAGED IN ANY PROFESSION, TRADE OR OCCUPATION B) TO ASSIST PERSONS WHO ARE IN CONDITIONS OF NEED HARDSHIP OR DISTRESS BY PROVIDING SERVICES OR FACILITIES CALCULATED TO REDUCE THE NEED HARDSHIP OR DISTRESS OF SUCH PERSONS

**Activities:** To make small grants to disadvantaged individuals resident in the borough of Walsall in particular for school uniforms and small household items; the charity cannot use any part of its income to make cash payments directly to individuals in relief of taxes, public funds etc.
