REPORT TO THE TRUSTEES

FOR THE YEAR ENDED 31 DECEMBER 2024

The trustees present their report with the financial statements of the Charity for the year ended 31 December 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (second edition, effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims of the charity

The Charity is established to maintain choral scholarships at the Cathedral School in the City of Hereford for boys resident in the Diocese of Hereford.

The Charity aims to fulfil its object set out above by sound investment management to maximise income concomitant with preservation of capital, to provide financial support for the cathedral choristers at Hereford Cathedral School. The main objective for the year is to maximise income to provide maximum support for choristers.

Significant activities

There were no new significant activities during the year ended 31 December 2024.

Public benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and in determining the grant making policy for the year.

Grantmaking

All grant making is in accordance with the provisions of the Charity Commission Scheme Sealed 1st December 1977.

ACHIEVEMENT AND PERFORMANCE

Review of progress and achievement

The charitable activity remains, as set out in the scheme, the provision of money for the establishment and maintenance of choral scholarships at the Cathedral School. The cost of these scholarships is a major part of the cost of the Cathedral's Choral Foundation, and it is unlikely that, without the aid of Tomson's Charity, the Chapter of Hereford Cathedral would be able to raise sufficient money to maintain the choir at its present strength.

Material Investments

The Charity draws its income from investments. A grant has been made to the Chapter of Hereford Cathedral to meet the cost of educating choristers and scholarships totalling £64,800 (2023: £64,000) during the year. Given the rising cost of the choral scholarships, the entire annual income of this Charity is insufficient to meet the shortfall between the costs of choral scholarships of £169,561 (2023: £186,833) and the income generated for this purpose in their own right by the Chapter of Hereford Cathedral. There is unlikely to be any further surplus income for the Charity in the future.

FINANCIAL REVIEW

Investment Powers

The trustees have wide powers of investment.

Investment policy and objectives

The trustees have considered the most appropriate policy for investing funds and consider that a mix of primarily UK and overseas equities complimented by fixed interest and alternative holdings meet their requirements to generate both income and capital growth.

To reflect more accurately the nature of the charity the trustees have decided to split the funds between the original endowment and the net income available after charging charity governance cost. This net income is recognised as unrestricted funds and is distributed to cover part of the annual cost of the Cathedral choral scholarships.

Reserves policy

The greater part of the Charity's assets is represented by its endowment. These funds are held as investments. The cost of managing investments in 2024 was £8,475 (2023: £8,347) and is charged against the endowment fund. Investments generated a net gain of £146,014 in 2024 (2023: £52,923). Total endowment net assets at the year-end amounted to £1,775,509 (2023: £1,671,182).

Income from investments is released to the unrestricted fund based on a 4% return of the market valuation of investments at 30th June of the 3 previous years. This income is applied as a grant to Chapter to help cover the cost of the choral scholarships. The dividend income generated by the investments in 2024 was £35,300 (2023: £43,730). The result for the year shows a decrease in unrestricted net income of £28 (2023: increase of £446). It is the policy of the trustees to maintain a small unrestricted fund to meet day-to-day costs. This stands at £1,494 on 31 December 2024 (2023: £1,522).

Risk review and Management

The main risk affecting the charity is poor performance of investments giving lower income returns. This is mitigated through good management of the funds as highlighted above. The trustees keep this under review at all times.

FUTURE PLANS

To continue to maximise income without jeopardising the capital base by constant review of investment performance for the better provision of choral scholarships.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Charity Commission Scheme Sealed 1 December 1977.

Recruitment and appointment of new trustees

The Charity Commission Scheme provides for the Chapter of Hereford Cathedral to be the trustees.

Organisational structure

The clerk to the trustees oversees the day-to-day operation of the Charity in accordance with the accounting instructions that have been adopted by the trustees. Administrative and financial duties are carried out by the trustees or delegated as appropriate.

Induction and training of new trustees

New members of Chapter are briefed on their duties as trustees as appropriate and attend courses covering the responsibilities of the trustees.

Opinion

We have audited the financial statements of Tomsons Charity (otherwise Richard Lane) for the year ended 31 December 2024 which comprise the statement of financial activities, the balance sheet and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

In our opinion, the financial statements:

- give a true and fair view of the state of the charity's affairs as at 31 December 2024 and of the charity's net movement in funds for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Charities Act 2011.

Basis for opinion

We have been appointed as auditor under section 144 of the Charities Act 2011 and report in accordance with the Act and relevant regulations made or having effect thereunder. We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the charity in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

In auditing the financial statements, we have concluded that the trustees' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the charity's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the trustees with respect to going concern are described in the relevant sections of this report.

Other information

The trustees are responsible for the other information. The other information comprises the information included in the Trustees' Annual Report. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Matters on which we are required to report by exception

We have nothing to report in respect of the following matters in relation to which the Charities (Accounts and Reports) Regulations 2008 require us to report to you if, in our opinion:

- adequate accounting records have not been kept by the charity; or
- sufficient accounting records have not been kept; or
- the charity financial statements are not in agreement with the accounting records and returns; or
- we have not received all the information and explanations we require for our audit.

Responsibilities of trustees for the financial statements

As explained more fully in the trustees' responsibilities statement set out on page 4, the trustees are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the trustees determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the trustees are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the trustees either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Extent to which the audit was capable of detecting irregularities, including fraud

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

We considered the nature of the charity's industry and its control environment and reviewed the charity's documentation of their policies and procedures relating to fraud and compliance with laws and regulations. We also enquired of management about their own identification and assessment of the risks of irregularities.

We obtained an understanding of the legal and regulatory framework that the charity operates in and identified the key laws and regulations that had a direct effect on the determination of material amounts and disclosures in the financial statements, including the UK Charities Act 2011 and tax legislation, and those that do not have a direct effect on the financial statements but compliance with which may be fundamental to the charity's ability to operate or to avoid a material penalty.

We discussed among the audit engagement team regarding the opportunities and incentives that may exist within the organisation for fraud and how and where fraud might occur in the financial statements.

In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override. In addressing the risk of fraud through management override of controls, we tested the appropriateness of journal entries and other adjustments; assessed whether the judgments made in accounting estimates are indicative of a potential bias; and evaluated the business rationale of any significant transactions that are unusual or outside the normal course of business.

In addition to the above, our procedures to respond to the risks identified included the following:

- reviewing financial statement disclosures by testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatements due to fraud;
- enquiring of management concerning actual and potential litigation and claims and instances of non-compliance with laws and regulations; and
- reading minutes of meetings of those charged with governance.



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention with the exception of investments which are included at market value, as modified by the revaluation of certain assets.

Going Concern

The accounts are prepared on a going concern basis, and, in the opinion of the directors, there is no material uncertainty in connection with the company's ability to continue to operate for the foreseeable future and a minimum of twelve months from the approval of the financial statements.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received, and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is not generally liable to corporation tax on its surplus. The charity is not registered for value added tax purposes.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

The investments, and any income and expenditure in managing the capital assets of the charity are recognised as part of the original endowment by the Tomson Charity and shown as Endowment Funds.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Investments

Investments are stated at market value at the balance sheet date and unrealised gains or losses are shown on the Statement of Financial Activities.

Liabilities

Liabilities are recognised when the Charity has a present obligation arising from past events.

Cash at bank and in hand

Cash at bank and cash in hand includes cash and short-term investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Debtors

Trade and other debtors are recognised at the settlement amount due. Prepayments are valued at the amount prepaid.

Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount.

REPORT TO THE TRUSTEES

FOR THE YEAR ENDED 31 DECEMBER 2023

The trustees present their report with the financial statements of the Charity for the year ended 31 December 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (second edition, effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims of the charity

The Charity is established to maintain choral scholarships at the Cathedral School in the City of Hereford for boys resident in the Diocese of Hereford.

The Charity aims to fulfil its object set out above by sound investment management to maximise income concomitant with preservation of capital, to provide financial support for the cathedral choristers at Hereford Cathedral School. The main objective for the year is to maximise income to provide maximum support for choristers.

Significant activities

There were no new significant activities during the year ended 31 December 2023.

Public benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and in determining the grant making policy for the year.

Grantmaking

All grant making is in accordance with the provisions of the Charity Commission Scheme Sealed 1st December 1977.

ACHIEVEMENT AND PERFORMANCE

Review of progress and achievement

The charitable activity remains, as set out in the scheme, the provision of money for the establishment and maintenance of choral scholarships at the Cathedral School. The cost of these scholarships is a major part of the cost of the Cathedral's Choral Foundation, and it is unlikely that, without the aid of Tomson's Charity, the Chapter of Hereford Cathedral would be able to raise sufficient money to maintain the choir at its present strength.

Material Investments

The Charity draws its income from investments. A grant has been made to the Chapter of Hereford Cathedral to meet the cost of educating choristers and scholarships totalling £64,000 (2022: £69,168) during the year. Given the rising cost of the choral scholarships, the entire annual income of this Charity is insufficient to meet the shortfall between the costs of choral scholarships of £186,833 (2022: £161,028) and the income generated for this purpose in their own right by the Chapter of Hereford Cathedral. There is unlikely to be any further surplus income for the Charity in the future.

FINANCIAL REVIEW

Investment Powers

The trustees have wide powers of investment.

Investment policy and objectives

The trustees have considered the most appropriate policy for investing funds and consider that a mix of primarily UK and overseas equities complimented by fixed interest and alternative holdings meet their requirements to generate both income and capital growth.

To reflect more accurately the nature of the charity the trustees have decided to split the funds between the original endowment and the net income available after charging charity governance cost. This net income is recognised as unrestricted funds and is distributed to cover part of the annual cost of the Cathedral choral scholarships.

FOR THE YEAR ENDED 31 DECEMBER 2023

Reserves policy

The greater part of the Charity's assets is represented by its endowment. These funds are held as investments. The cost of managing investments in 2023 was £8,347 (2022 £10,404) and is charged against the endowment fund. Investments generated a net gain of £52,923 in 2023 (2022 net loss of £262,799). Total endowment net assets at the year-end amounted to £1,671,182 (2022: £1,651,044).

Income from investments is released to the unrestricted fund based on a 4% return of the market valuation of investments at 30th June of the 3 previous years. This income is applied as a grant to Chapter to help cover the cost of the choral scholarships. The dividend income generated by the investments in 2023 was £43,730 (2022: £40,422). The result for the year shows an increase in unrestricted net income of £446 (2022: decrease of £3,690). It is the policy of the trustees to maintain a small unrestricted fund to meet day-to-day costs. This stands at £1,522 on 31 December 2023 (2022: £1,076).

Risk review and Management

The main risk affecting the charity is poor performance of investments giving lower income returns. This is mitigated through good management of the funds as highlighted above. The trustees keep this under review at all times.

FUTURE PLANS

To continue to maximise income without jeopardising the capital base by constant review of investment performance for the better provision of choral scholarships.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Recruitment and appointment of new trustees

The Charity Commission Scheme provides for the Chapter of Hereford Cathedral to be the trustees.

Organisational structure

The clerk to the trustees oversees the day-to-day operation of the Charity in accordance with the accounting instructions that have been adopted by the trustees. Administrative and financial duties are carried out by the trustees or delegated as appropriate.

Induction and training of new trustees

New members of Chapter are briefed on their duties as trustees as appropriate and attend courses covering the responsibilities of the trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention with the exception of investments which are included at market value, as modified by the revaluation of certain assets.

Going Concern

The accounts are prepared on a going concern basis, and, in the opinion of the directors, there is no material uncertainty in connection with the company's ability to continue to operate for the foreseeable future and a minimum of twelve months from the approval of the financial statements.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received, and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is not generally liable to corporation tax on its surplus. The charity is not registered for value added tax purposes.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

The investments, and any income and expenditure in managing the capital assets of the charity are recognised as part of the original endowment by the Tomson Charity and shown as Endowment Funds.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Investments

Investments are stated at market value at the balance sheet date and unrealised gains or losses are shown on the Statement of Financial Activities.

Liabilities

Liabilities are recognised when the Charity has a present obligation arising from past events.

Cash at bank and in hand

Cash at bank and cash in hand includes cash and short-term investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Debtors

Trade and other debtors are recognised at the settlement amount due. Prepayments are valued at the amount prepaid.

Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount.

REPORT TO THE TRUSTEES

FOR THE YEAR ENDED 31 DECEMBER 2022

The trustees present their report with the financial statements of the charity for the year ended 31 December 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

OBJECTIVES AND ACTIVITIES

Objectives and aims of the charity

The Charity is established to maintain choral scholarships at the Cathedral School in the City of Hereford for boys resident in the Diocese of Hereford.

The Charity aims to fulfil its object set out above by sound investment management to maximise income concomitant with preservation of capital, to provide financial support for the cathedral choristers at Hereford Cathedral School. The main objective for the year is to maximise income to provide maximum support for choristers.

Significant activities

There were no new significant activities during the year ended 31 December 2022.

Public benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and in determining the grant making policy for the year.

Grantmaking

All grant making is in accordance with the provisions of the Charity Commission Scheme Sealed 1st December 1977.

ACHIEVEMENT AND PERFORMANCE

Review of progress and achievement

The charitable activity remains, as set out in the scheme, the provision of money for the establishment and maintenance of choral scholarships at the Cathedral School. The cost of these scholarships is a major part of the cost of the Cathedral's Choral Foundation and it is unlikely that, without the aid of Tomson's Charity, the Chapter of Hereford Cathedral would be able to raise sufficient money to maintain the choir at its present strength.

Material Investments

The Charity draws its income from investments. Income has been made over to the Chapter of Hereford Cathedral to meet the cost of educating choristers and scholarships totalling £69,168 (2021: £66,360) during the year. Given the rising cost of the choral scholarships, the entire annual income of this Charity is insufficient to meet the shortfall between the costs of choral scholarships of £161,028 (2021: £151,710) and the income generated for this purpose in their own right by the Chapter of Hereford Cathedral. There is unlikely to be any further surplus income for the Charity in the future.

FINANCIAL REVIEW

Investment Powers

The trustees have wide powers of investment.

Investment policy and objectives

The trustees have considered the most appropriate policy for investing funds and consider that a mix of primarily UK and overseas equities complimented by fixed interest and alternative holdings meet their requirements to generate both income and capital growth.

To reflect more accurately the nature of the charity the trustees have decided to split the funds between the original endowment and the net income available after charging charity governance cost. This net income is recognised as unrestricted funds and is distributed to cover part of the annual cost of the Cathedral choral scholarships.

FOR THE YEAR ENDED 31 DECEMBER 2022

Reserves policy

The greater part of the charity's assets is represented by its endowment. These funds are held as investments. The cost of managing investments in 2022 was £10,404; (2021 £8,719) is charged against the endowment fund. Investments generated a net loss of £262,799 in 2022 (2021 net gain of £260,307). Total endowment net assets at the year-end amounted to £1,651,044 (2021: £1,952,994).

Income from investments is released to the unrestricted fund based on a 4% return of the market valuation of investments at 30th June of the 3 previous years. This income is applied as a grant to Chapter to help cover the cost of the choral scholarships. The dividend income generated by the investments in 2022 was £40,421 (2021: £33,792). The result for the year shows a decrease in unrestricted net income of £3,690 (2021: decrease of £3,321). It is the policy of the trustees to maintain a small unrestricted fund to meet day-to-day costs. This stands at £1,076 at 31 December 2022 (2021: £4,766).

Risk review and Management

The main risk affecting the charity is poor performance of investments giving lower income returns. This is mitigated through good management of the funds as highlighted above. The trustees keep this under review at all times.

FUTURE PLANS

To continue to maximise income without jeopardising the capital base by constant review of investment performance for the better provision of choral scholarships.

The Charity Commission Scheme provides for the Chapter of Hereford Cathedral to be the trustees.

Organisational structure

The clerk to the trustees oversees the day-to-day operation of the Charity in accordance with the accounting instructions that have been adopted by the trustees. Administrative and financial duties are carried out by the trustees or delegated as appropriate.

New members of Chapter are briefed on their duties as trustees as appropriate and attend courses covering the responsibilities of the trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 10) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 20'5)', Financial Reporting Standard 1'2 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention with the exception of investments which are included at market value, as modified by the revaluation of certain assets.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is not generally liable to corporation tax on its surplus. The charity is not registered for value added tax purposes.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

The investments, and any income and expenditure in managing the capital assets of the charity are recognised as part of the original endowment by the Tomson Charity and shown as Endowment Funds.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Investments

Investments are stated at market value at the balance sheet date and unrealised gains or losses are shown on the Statement of Financial Activities.

Liabilities

Liabilities are recognised when the Charity has a present obligation arising from past events.

Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Debtors

Trade and other debtors are recognised at the settlement amount due. Prepayments are valued at the amount prepaid.

Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount

REPORT TO THE TRUSTEES

FOR THE YEAR ENDED 31 DECEMBER 2021

The trustees present their report with the financial statements of the charity for the year ended 31 December 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

OBJECTIVES AND ACTIVITIES

Objectives and aims of the charity

The Charity is established to maintain choral scholarships at the Cathedral School in the City of Hereford for boys resident in the Diocese of Hereford.

The Charity aims to fulfil its object set out above by sound investment management to maximise income concomitant with preservation of capital, to provide financial support for the cathedral choristers at Hereford Cathedral School. The main objective for the year is to maximise income to provide maximum support for choristers.

Significant activities

There were no new significant activities during the year ended 31 December 2021.

Public benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and in determining the grant making policy for the year.

Grantmaking

All grant making is in accordance with the provisions of the Charity Commission Scheme Sealed 1st December 1977.

ACHIEVEMENT AND PERFORMANCE

Review of progress and achievement

The charitable activity remains, as set out in the scheme, the provision of money for the establishment and maintenance of choral scholarships at the Cathedral School. The cost of these scholarships is a major part of the cost of the Cathedral's Choral Foundation and it is unlikely that, without the aid of Tomson's Charity, the Chapter of Hereford Cathedral would be able to raise sufficient money to maintain the choir at its present strength.

Material Investments

The Charity draws its income from investments. Income has been made over to the Chapter of Hereford Cathedral to meet the cost of educating choristers and scholarships totalling £66,360 (2020: £64,000) during the year. Given the rising cost of the choral scholarships, the entire annual income of this Charity is insufficient to meet the shortfall between the costs of choral scholarships of £151,710 (2020: £150,358) and the income generated for this purpose in their own right by the Chapter of Hereford Cathedral. There is unlikely to be any further surplus income for the Charity in the future.

FINANCIAL REVIEW

Investment Powers

The trustees have wide powers of investment.

Investment policy and objectives

The trustees have considered the most appropriate policy for investing funds and consider that a mix of primarily UK and overseas equities complimented by fixed interest and alternative holdings meet their requirements to generate both income and capital growth.

To reflect more accurately the nature of the charity the trustees have decided to split the funds between the original endowment and the net income available after charging charity governance cost. This net income is recognised as unrestricted funds and is distributed to cover part of the annual cost of the Cathedral choral scholarships.

FOR THE YEAR ENDED 31 DECEMBER 2021

Reserves policy

The greater part of the charity's assets is represented by its endowment. These funds are held as investments. The cost of managing investments 2021 £8,719; (2020 £5,694) is charged against the endowment fund. Investments generated a net gain of £260,307 in 2021 (2020 net gain of £17,005). Total endowment net assets at the year-end amounted to £1,952,994 (2020: £1,733,974).

Income from investments is released to the unrestricted fund based on a 4% return of the market valuation of investments at 30th June of the 3 previous years. This income is applied as a grant to Chapter to help cover the cost of the choral scholarships. The dividend income generated by the investments in 2021 was £33,792 (2020 £37,265). The result for the year shows a decrease in unrestricted net income of £3,779 (2020: decrease of £78). It is the policy of the trustees to maintain a small unrestricted fund to meet day-to-day costs. This stands at £4,766 at 31 December 2021 (2020: £8,087).

Risk review and Management

The main risk affecting the charity is poor performance of investments giving lower income returns. This is mitigated through good management of the funds as highlighted above. The trustees keep this under review at all times.

FUTURE PLANS

To continue to maximise income without jeopardising the capital base by constant review of investment performance for the better provision of choral scholarships.

The Charity Commission Scheme provides for the Chapter of Hereford Cathedral to be the trustees.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention with the exception of investments which are included at market value, as modified by the revaluation of certain assets.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is not generally liable to corporation tax on its surplus. The charity is not registered for value added tax purposes.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

The investments, and any income and expenditure in managing the capital assets of the charity are recognised as part of the original endowment by the Tomson Charity and shown as Endowment Funds.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Investments

Investments are stated at market value at the balance sheet date and unrealised gains or losses are shown on the Statement of Financial Activities.

Liabilities

Liabilities are recognised when the Charity has a present obligation arising from past events.

Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Debtors

Trade and other debtors are recognised at the settlement amount due. Prepayments are valued at the amount prepaid.

Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount

The trustees present their report with the financial statements of the charity for the year ended 31 December 2020. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

OBJECTIVES AND ACTIVITIES

Objectives and aims of the charity

The Charity is established to maintain choral scholarships at the Cathedral School in the City of Hereford for boys resident in the Diocese of Hereford.

The Charity aims to fulfil its object set out above by sound investment management to maximise income concomitant with preservation of capital, to provide financial support for the cathedral choristers at Hereford Cathedral School. The main objective for the year is to maximise income to provide maximum support for choristers.

Significant activities

There were no new significant activities during the year ended 31 December 2020.

Public benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and in determining the grant making policy for the year.

Grantmaking

All grant making is in accordance with the provisions of the Charity Commission Scheme Sealed 1st December 1977.

ACHIEVEMENT AND PERFORMANCE

Review of progress and achievement

The charitable activity remains, as set out in the scheme, the provision of money for the establishment and maintenance of choral scholarships at the Cathedral School. The cost of these scholarships is a major part of the cost of the Cathedral's Choral Foundation and it is unlikely that, without the aid of Tomson's Charity, the Chapter of Hereford Cathedral would be able to raise sufficient money to maintain the choir at its present strength.

Material Investments

The Charity draws its income from investments. Income has been made over to the Chapter of Hereford Cathedral to meet the cost of educating choristers and scholarships totalling £65,824 (2019: £61,468) during the year. Given the rising cost of the choral scholarships, the entire annual income of this Charity is insufficient to meet the shortfall between the costs of choral scholarships of £150,358 (2019: £165,359) and the income generated for this purpose in their own right by the Chapter of Hereford Cathedral. There is unlikely to be any further surplus income for the Charity in the future.

FINANCIAL REVIEW

Investment Powers

The trustees have wide powers of investment.

Investment policy and objectives

The trustees have considered the most appropriate policy for investing funds and consider that a mix of primarily UK and overseas equities complimented by fixed interest and alternative holdings meet their requirements to generate both income and capital growth.

To reflect more accurately the nature of the charity the trustees have decided to split the funds between the original endowment and the net income available after charging charity governance cost. This net income is recognised as unrestricted funds and is distributed to cover part of the annual cost of the Cathedral choral scholarships.

Reserves policy

The greater part of the charity's assets is represented by its endowment. These funds are held as investments. The cost of managing investments (2020 £5,694; 2019 £8,415) is charged against the endowment fund. Investments generated a net gain of £17,005 in 2020 (2019 net gain of £219,536). Total endowment net assets at the year-end amounted to £1,733,974 (2019: £1,751,222).

Income from investments is released to the unrestricted fund based on a 4% return of the market valuation of investments at 30th June of the 3 previous years. This income is applied as a grant to Chapter to help cover the cost of the choral scholarships. The dividend income generated by the investments in 2020 was £37,265 (2019 £52,902). The result for the year shows a decrease in unrestricted net income of £78 (2019: decrease of £1,585). It is the policy of the trustees to maintain a small unrestricted fund to meet day-to-day costs. This stands at £8,087 at 31 December 2020 (2019: £8,165).

Risk review and Management

The main risk affecting the charity is poor performance of investments giving lower income returns. This is mitigated through good management of the funds as highlighted above. The trustees keep this under review at all times.

FUTURE PLANS

To continue to maximise income without jeopardising the capital base by constant review of investment performance for the better provision of choral scholarships.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Charity Commission Scheme Sealed 1 December 1977.

Recruitment and appointment of new trustees

The Charity Commission Scheme provides for the Chapter of Hereford Cathedral to be the trustees.

Organisational structure

The clerk to the trustees oversees the day-to-day operation of the Charity in accordance with the accounting instructions that have been adopted by the trustees. Administrative and financial duties are carried out by the trustees or delegated as appropriate.

New members of Chapter are briefed on their duties as trustees as appropriate and attend courses covering the responsibilities of the trustees.





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention with the exception of investments which are included at market value, as modified by the revaluation of certain assets.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is not generally liable to corporation tax on its surplus. The charity is not registered for value added tax purposes.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

The investments, and any income and expenditure in managing the capital assets of the charity are recognised as part of the original endowment by the Tomson Charity and shown as Endowment Funds.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Investments

Investments are stated at market value at the balance sheet date and unrealised gains or losses are shown on the Statement of Financial Activities.

Liabilities

Liabilities are recognised when the Charity has a present obligation arising from past events.

Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

Debtors

Trade and other debtors are recognised at the settlement amount due. Prepayments are valued at the amount prepaid.

Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount
