### STRUCTURE AND MANAGEMENT

THE CHARITY IS UNINCORPORATED, WITH ITS OWN MODEL CONSTITUTION. THE PRINCIPAL OBJECTIVES OF THE SOCIETY, AS DEFINED IN ITS CONSTITUTION, ARE TO PROVIDE HELP AND SUPPORT FOR PEOPLE WITH LEARNING DIFFICULTIES BY WAY OF FACILITIES FOR LEARNING AND RECREATION, TO IMPROVE THEIR CONDITION OF LIFE.

THE COMMITTEE IS ELECTED / REELECTED BY MEMBERS OF THE SOCIETY AT EACH YEARS AGM, AS SET OUT IN SECTION 5 OF THE CONSTITUTION. TRUSTEES ARE NOMINATED AND APPOINTED BY MEMBERS OF THE COMMITTEE. OPERATIONAL DECISIONS ARE MADE BY THE COMMITTEE.

EVERYONE ACTS ON A VOLUNTARY BASIS. NO ONE IS PAID.

### ACTIVITIES, OBJECTIVES, ACHIEVEMENTS AND PERFORMANCE

SINCE OUR INCEPTION IN THE 1980'S, WE HAVE CONTINUED TO PROVIDE EVENING CLASSES FOR PEOPLE WITH LEARNING DIFFICULTIES, OPERATING ON MONDAY AND THURSDAY EACH WEEK FROM 7PM TO 9PM DURING SCHOOL TERM TIMES - 36 WEEKS EACH YEAR. WE PAY TUTORS ON A SELF EMPLOYED BASIS - 9 CURRENTLY, WHO TEACH CLASSES ON COOKERY, MUSIC, PHOTOGRAPHY, GARDENING, POTTERY, ART AND SEWING.

APPROXIMATELY 40 PEOPLE ATTEND, SOME ATTENDING FOR MORE THAN 20 YEARS NOW, AND NEW STARTERS COMING WHEN SPACES AVAILABLE. TRANSPORT IS PROVIDED FOR THOSE WHO NEED IT, WE SUBSIDISE THE COST, PAYING 60% OURSELVES, AND CHARGING 40% FROM THE STUDENTS. WE HAVE USE OF A LOCAL DISABILITY RESOURCE CENTRE FOR THE CLASSES.

BOTH THOSE ATTENDING AND PARENTS/FAMILY APPRECIATE HAVING THE CHANCE TO GET OUT AND DO SOMETHING DIFFERENT AWAY FROM HOME LIFE.

WE FEEL WE PROVIDE A VALUABLE SERVICE FOR AN OFTEN NEGLECTED SECTION OF THE COMMUNITY.

### FINANCIAL REVIEW


WE HAVE ALWAYS BEEN SELF SUPPORTING, RELYING ENTIRELY ON FUNDRAISING TO RUN OUR OPERATION. OUR FUNDRAISING CAPABILITIES ARE NOW VERY LIMITED. IT CAME TO A STAGE WHERE, WITH MEMBERS AND COMMITTEE/TRUSTEES BECOMING OLDER, IT WAS DECIDED THAT THE WAY FORWARD WOULD BE TO USE ACCUMULATED FUNDS TO FINANCE THE CONTINUING OPERATION OF OUR EXISTING FACILITIES UNTIL THE MONEY IS ALL SPENT.

WE ESTIMATE COSTS AGAINST INCOME WILL LEAVE APPROXIMATELY £40,000 SPENT EACH YEAR. ENOUGH MONEY TO CONTINUE FOR AROUND 20 YEARS, WHICH IS FELT THE BEST WAY FORWARD. FUNDS ARE INVESTED MOSTLY IN A LOW RISK UNIT TRUST INVESTMENT, WITH AN ADDITIONAL AMOUNT IN BANK INSTANT ACCESS ACCOUNT. AVERAGING OVER 10% GAIN EACH YEAR OVER THE PAST 10 YEARS, THE UNIT TRUST HAS PROVED A GOOD INVESTMENT.

WE HAVE NO DEBTS, AND NO FUNDS ARE HELD WHERE WE ARE CUSTODIAN TRUSTEES.

### Notes to the Financial Statements for the Year Ended 30 September 2024

#### 1. ACCOUNTING POLICIES

##### **Basis of preparing the financial statements**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

##### **Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

##### **Expenditure**

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

##### **Taxation**

The charity is exempt from tax on its charitable activities.

##### **Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
