STRUCTURE, GOVERNANCE AND MANAGEMENT

The College was established by Trust Deed dated 15 March 1962, supplemented by a Deed of Variation of Trust dated 27 November 1968 and with further variations to the Deed of Trust in 2011 and 2018.

Trustees

The College is managed by the Trustees of the Charity, sitting as an Executive Committee. The Executive can also vote on to the Committee other Members as they see fit. All other members of the Executive except the Treasurer are Trustees.

Organisation

The Executive Committee met regularly in 2024, by Zoom on most occasions with the Director of Training. The members of the Committee are, if necessary, consulted by email on major issues.

Within the policy set by the Executive Committee the responsibility for the day-to-day training activities is delegated to the Director of Training. The administration of the College continues to be handled by the Trustees together with the Treasurer as a co-opted member.

Members of the Executive Committee are a strategic body with individuals taking responsibility for specific projects and reporting back to the Committee.

We are thankful for the services of our Director of Training who continues to contribute significantly to the work of the College.

Related Parties

Since January 2018 Hymns Ancient and Modern have published "The Preacher" magazine, paying a commission to the College to do so.

Risk Management

The Trustees regularly review the risks that the College might face, which normally relate to the level of membership and the finances of the College. They consider that arrangements have been set up to mitigate such risks as have been identified. No major risks have been identified at this stage and the review of risks is now an on-going task in accordance with the advice of the Charity Commission.

OBJECTIVES AND ACTIVITIES

Objectives

The primary object of the College is the advancement and promotion of religion generally and in particular by the provision of religious education and training. The College is ecumenical and covers all Christian denominations. Subsidiary purposes contained in the original Trust Deed include: the establishment and maintenance of a college to assist those who are engaged in preaching and teaching the word of God; and the organisation of courses of lectures and the provision of individual tuition to those engaged in preaching.

Activities

The Activities employed to achieve the College's objectives include:

- publishing a quarterly journal (The Preacher) with articles on preaching, outline sermons relating to the lectionaries in general use and other material relevant to preachers,
- holding short courses on various aspects of preaching, either at the request of particular religious groups or on an open basis,
- holding occasional major residential conferences and other events on preaching,
- maintaining a website (www.collegeofpreachers.co.uk) aimed at supporting preachers,
- providing advice and support to persons engaged in preaching and those training preachers.

Public Benefit

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit. They consider that the College is of public benefit by, inter alia, encouraging the proclamation of the Christian religion; encouraging ecumenical cooperation between different strands of Christianity; and providing unrestricted education in skills and methods of public speaking.

REPORT ON THE COLLEGE AND ON ITS ACTIVITIES FOR THE YEAR TO 31 DECEMBER 2024.

FINANCIAL REVIEW

The financial results for the year were again satisfactory, resulting in an operating surplus for the year of £1,157 (2023 £2,615), which was increased, by the increase in the value of investments, to £2,715 (2023 £8,466).

In 2024 the College's incoming resources were £22,564 slightly down on 2023 of £23,115. With expenditure of £21,407, (2023 £20,500) this led to the modest operating surplus of £1,157 (2023 £2,615). However, £2,758 has been paid as a non-refundable deposit for the 2025 conference.

Commission from subscriptions to the Preacher magazine continues to be the main source of income at £13,814 (2023 £14,370) although this was lower due to one off investment in the website. Subscriptions for 2024 were some 1074 (2023: 1016).

The value of the investments at the year-end was £69,596 (2023: £68,038). This together with the modest surplus has resulted in a balance of funds carried forward at the end of the year of £106,145 (2023 £103,430).

Reserves

To enable the College to maintain its core activities, the Trustees consider that liquid reserves equivalent to at least twelve months regular operating expenditure are required. As will be seen from the details in the accounts, whilst more than this is held at present, the Trustees consider the finances to be satisfactory, given challenges in the future.

Report on the Editorial Board 2024

'The Preacher' is the quarterly journal of The College of Preachers. It contains complete sermons for every Sunday or red-letter day in the quarter in question – a practical resource to refer to every week. It also contains book reviews; news of training opportunities from the College and Festivals of Preaching; and feature articles – which focus on a different theme for each edition. The four themes featured in 2024 were 'Learning preaching', 'Preaching as a performance', 'Novels and preaching' and 'Eschatology'. Future themes in the planning stages include 'The Epistles', 'Reaching Generation Z', 'Racial justice' and 'Preaching stars (learning from the past)'.

Subscriptions for the journal have continued to increase steadily, reaching approximately 1,100 by the end of the year.

Responsibility for putting the journal and its accompanying website together rested this year with Heather Smith of Hymns Ancient and Modern ('Hymns') – the Managing Editor – and Emily Noyce, also from Hymns, the Marketing Executive. On the College side they were joined by Matt Allen, Reviews and Resources Editor; Duncan Macpherson, Features Editor; and Graham Pearcey, Rob Esdaile and Catherine Williams, Commissioning Editors for sermons from Nonconformist, Roman Catholic and Anglican preachers. Last but not least the role of Editor transitioned seamlessly during the course of 2024 from Christopher Burkett, who'd carried out this role for an amazing eleven years, to Jo Logan, the Director of Reader Training at St Hild College, Mirfield.

The Editorial Board are particularly proud not only of their own ecumenical makeup but also of the diversity of authors who submitted articles, reviews and sermons – which this year included lay and ordained preachers and academics from Catholic, Greek, Anglican, Methodist, United Reformed, Baptist, Church of Scotland, Nazarene, Salvation Army, Congregational Federation, and a wide range of Black majority traditions.

Preacher Training 2024

Activities

There were a wide-ranging programme of workshops in 2024. We held eleven on-line workshops, and two in-person workshops. On-line workshops averaged 23 bookings per workshop and each of the in-person workshops had approximately 10 bookings. We provided two bespoke training events in 2024, one for Bristol Diocese and one that involved providing 3 tutors to create training materials for Oxford Diocese.

We joined BlueSky and continue to have accounts on Instagram and Threads and left Twitter in December 2024. Posts have mainly been to promote workshops and have primarily been done by the Director of Training. In Advent, the Director did a daily post of a 'thought for the day' reflection to all our social media accounts. Although the number of followers we have on these platforms is still relatively small, we continue to gain new followers.

Mailings about workshops and other events were managed by Hymns and mailings for workshops were sent by the Director to Church of England and Roman Catholic dioceses, other denominations, TEIs and other theological colleges.

Preachers' Forum and other Resources

The Preachers' Forum is a monthly online meeting in which preachers have a space to discuss together a particular topic relevant to preaching, a theme for preaching, or select biblical passages. This does not include any 'top-down' input from a tutor or other expert but is instead an opportunity for peer-to-peer learning, sharing of experience and good practice, and mutual encouragement. Attendance varies but is generally between 15 and 20 people.

We now have seven videos available for people to view on the website. These cover a range of subjects, from the webinars that we recorded during lockdown in 2020, the panel discussion on intercultural preaching, recorded in 2021, to interviews on preaching about farmed animal welfare, about money, about the importance of the Old Testament for preaching, and preaching about safeguarding.


Future Projects

The conference initially planned for 2024 had to be postponed to 2025 because of a clash with Hymns Ancient & Modern's Festival of Preaching. The new dates are 9–11 September 2025. The theme of the conference is 'The Wonder of Words'. Dr Margaret Cooling, author and lay preacher, will be the keynote speaker. There will be a range of workshops on the use of words in preaching.

Basis of independent examiner's report





NOTES TO THE FINANCIAL STATEMENTS

Accounting Policies

The financial statements have been prepared using the Accruals basis.

The accounts include all monetary transactions, assets and liabilities for which the Trust is responsible in law.

Funds

Unrestricted funds are general funds which can be used for the Trust's ordinary purposes.

Restricted funds represent (a) donations or grants received for a specific object or invited by the Trust for a specific object, and (b) income from trusts and endowments which may be expended only on those restricted objects provided in the terms of the trust of bequest. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of the year must be carried forward as a balance on that fund. There are currently no restricted funds.

The following assets are recognised and a monetary value given as part of the description in the Balance Sheet: Bank and deposit accounts; Amounts owing from HMRC where a formal claim has been made; Investment assets.

Liabilities are recognised and a monetary value given in the Balance Sheet where the supply had been received by 31 December.
