Structure, governance and management

The method of appointment of Council members is set out in a Trust Deed dated 14th March 1983, amended by resolution dated 13th July 2007. The body of trustees shall consist of five nominative trustees, appointed by the Bishop of Leeds and two Co-optative trustees appointed by a resolution of the trustees.

Objects and activities

The object of the Charity is to support and further all or any charitable purposes carried out in connection with that part of the religious and other charitable work of the Church of England in the Diocese of Leeds which relates to social and moral welfare, in one or more of the following ways as the Trustees think fit:

- (1) In furthering education in the basic principles of Christian morality;
- (2) In promoting and maintaining the spiritual teaching of the Church of England and the doctrines and observances that serve to manifest such teaching;
- (3) In promoting a higher standard of moral life in the individual, the family and the community;
- (4) In assisting and guiding those persons who by reason of difficulty in their personal relationships or otherwise are in need of material assistance or moral guidance.

Achievements and performance

The Council met once in 2022 and gave grants during the year in accordance with the purposes of the Trusts' objectives to the value of £26,300. One cheque to the value of £4,900 was not presented to the bank until 2023, and also, an additional grant from 2021 of £850 was issued in 2022. Therefore £22,250 is showing in these accounts. The Trust supported five projects with grants ranging from £4,000 to £6,400. A £4,977 grant awarded to Christian Nightlife Initiative in 2020 has been returned in the year as the project is no longer running.

Financial review

The income was entirely from the investments, consisting of dividends and interest.

Interest and dividends received during the year amounted to £24,158 which was £1,378 greater than 2021. Dividend receipts from the Share Fund investments increased during the year, being £669 greater than 2021. Dividend receipts from the Property Fund investments increase, being £63 higher than in 2021.

Income was higher than grants awarded and council expenses by £6,733.

The market value of the share investments decreased in value by £90,773 during the year.
The market value of the property fund investments decreased in value by £8,232 during the year
The overall decrease in the market value of the investments was 11.72%

Our reserve policy is to maintain a year's worth of grants in cash and deposits, which is approximately £25,000 based on the average of the previous three years. The balance of the cash and deposits at year-end was £46,980 but total reserves stood at £792,692. The excess reserves are invested to generate future income.

Going concern

The Trustees have prepared these financial statements on a going concern basis.

The Trustees have reviewed the financial and operational risks.

The Charity's income is from invested funds and if returns were to reduce the Trustees are able to reduce the level of grants awarded.

1. ACCOUNTING POLICY

Basis of accounting

The financial statements are prepared under the historic cost convention as modified by the revaluation of investments in accordance with applicable accounting standards and the Statement of Recommended Practice for Charities.

Investments

Investments are stated at Bid Market Value. Realised and Unrealised gains/losses are reflected in the statement of Financial Activities.

Reserves Policy

Our reserve policy is to maintain a year's worth of grants in cash and deposits, which is approximately £25,000 based on the average of the previous three years. The balance of the cash and deposits at year-end was £46,980 but total reserves stood at £792,692. The excess reserves are invested to generate future income.
