TRUSTEES' REPORT

OBJECTIVES AND ACTIVITIES

The charity's objective is the provision of almshouses to almswomen in the Rotherham area. The trustees have considered the Charity Commission's guidance on public benefit and consider that its' activities promote the welfare of aged and needy people and therefore meet the public benefit requirements.

PUBLIC BENEFIT

In setting plans and priorities for areas of work, the trustees of Mary Bellamy's Charity have had regard to the guidance from the charity commission on the provision of public benefit.

The public benefit arising from Mary Bellamy's Charity can be seen in the continued provision of a suitable standard of accommodation for Almswomen in the local area. This is in line with the Charity's activities and objectives to make available Almshouses to Almswomen in the community and is met by providing six such houses on Bellamy Close, Rotherham.

The properties are provided for gentlewomen of good character who are in reduced, needy or indigent circumstances.

The Charity also aims to support relevant elderly individuals in the community with other additional services they provide.

ACHIEVEMENTS, PERFORMANCE AND FINANCIAL REVIEW

The charity continued to provide six almshouses at Bellamy Close, Herringthorpe.

The year end financial position of the charity is satisfactory. As set out on pages seven and eight, the market value of investments at 31 December 2024 was £540,218 which is £406,119 in excess of their original cost. The unrealised gain on investments for the year was £14,812 (2023 - £18,487).

The trustees have considered the requirement for reserves and judged that the current level remains adequate.

The amount of reserves held by the charity as at 31 December 2024 is £810,929 (2023 - £793,966) which is made up of bank balances totalling £128,067 (2023 - £126,134), investments of £540,218 (2023 - £525,406), fixed assets of £150,000, debtors of £1,179 (2023 - £715), less liabilities of £8,535 (2023 - £8,289). The fixed assets are made up of land and buildings which are held in order to achieve one of the main objectives of the charity of providing almshouse to local women. The bank balances are held to allow the day to day management of the properties as well as a reserve in case repairs are required to the property. The investments are held as endowment funds.

Most of the charity's income is generated from investments and current returns are consistent to last year.

INVESTMENT POLICY / PERFORMANCE

The trustees take advice from stockbrokers in connection with the acquisition and disposal of investments and the operation of the portfolio.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governing instrument of the Charity is a scheme of the Charity Commissioners dated 12 June 1968.

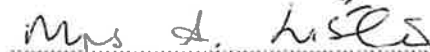
The charity is run by a clerk and a board of unpaid trustees. Administrative duties are carried out by the solicitors to the charity.
