Report of the Trustees **for the Year Ended 5 April 2022**

The trustees present their report with the financial statements of the charity for the year ended 5 April 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The society is established for charitable objects and purposes only.

The objectives of the charity include:

1. To promote the care, interest, treatment, education and advancement of all people with cerebral palsy and associated disabilities and the welfare of their parents and carers.
2. To provide emotional support, friendship and advice to those affected by cerebral palsy.
3. To facilitate access to a support network and community of volunteers, other members with cerebral palsy and their families.
4. To offer members subsidised short breaks and to purchase, take on lease or otherwise acquire real or personal property as appropriate to meet this objective.
5. To offer other subsidised therapies as available.
6. To make grants to assist with equipment and items that need to be purchased to be of benefit to people with cerebral palsy

General background and public benefit

During the last twelve months a number of events have taken place to carry out the charity objectives these include:

1. Children's Parties;
2. Adult Dinner dance;
3. Funded swimming sessions for members;
4. Grants have been awarded to members to assist with purchasing equipment;
5. Coffee mornings;
6. Education and training courses have been held;
7. The holiday home at Bridlington has had some improvements and bookings have been good;
8. The caravan has been used for short breaks for members and their families

Achievements and performance

This year the charity has achieved its objectives, further information is set out in the public benefit.



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention, with the exception of investments which are included at market value.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Freehold property	- Nil
Fixtures and fittings	- 15% on cost and 10% on reducing balance
Motor vehicles	- 25% on cost
Computer equipment	- 25% on reducing balance

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
