TRUSTEES REPORT

The Trustees present their annual report and financial statements for the year ended 30th September 2025

OBJECTIVES AND ACTIVITIES

The objectives of the Charity are to improve the lives and opportunities of children and adults with a learning disability together with their families and carers. To listen to and support people with a learning disability in all parts of their lives and to give information and advice.

The main objectives in the year continued to be the provision of leisure opportunities for the Charity's beneficiaries.

Review of charitable of charitable activities for the public benefit

The Charity's aim is to provide a variety of supported leisure activities in order to enable its members to socialise with their peers by attendance at clubs or by taking part in events in a range of mainstream locations and facilities.

The Trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the Charity should undertake.

This provision is provided by the services described in the achievements and performance set out in the next section.

Achievements and performance

West Norfolk Mencap provided the following services in the year:

Senior Gateway Club: A club held once every fortnight in the evening for adults with a learning disability and aged 18+. A wide range of activities are organised and the club is very popular with 40 to 50 members with generally more than 30 people attending. The club is run by 4 to 6 volunteers. Some members are dropped off or attend independently with others being supported by their carers if their needs require it. The maximum for membership is set at 50 in order to provide a safe environment. This occasionally leads to a waiting list.

Junior Gateway: A smaller club for young people under the age of 18 held one evening every week during term time. Membership of this club has been dwindling in recent years with only a handful of people turning up on some occasions. Sadly, in the autumn of 2025 the Trustees decided to close the club as the need for it no longer existed. Formal closure took place in December 2025.

Befriender Scheme: The Befriender Scheme organises group outings and social events for members with the aim of helping them enjoy visits to mainstream locations such as pubs, restaurants, tourist attractions, boat trips, cinemas etc. This a very popular service with events being booked up within days of issue of the quarterly programmes.

Advocacy Service: the Charity offers a small advocacy service with one volunteer trained as an independent advocate. Support is provided to members and non-members on request.

Health Appointments Transport: West Norfolk Mencap has received grant funding from the local Integrated Care Board to promote and support people with a learning disability attending health check and other health appointments. As part of this project the charity offers free transport to and from appointments.

Beach Hut: West Norfolk Mencap is fortunate own a large beach hut at Old Hunstanton. This made available to free of charge to individuals, families and organisations with a learning disability connection. When not booked then local schools and other charities are given the opportunity to use it. Donations received from users help with maintenance costs. Over the last two years over £20,000 has been spent on major refurbishment including construction of a large new veranda. Grant support of £7,500 and £4,000 was received from the Borough Council of King's Lynn and West Norfolk and Morrisons respectively. The balance was covered from the charity's own funds.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity is governed by constitution and is run as an unincorporated charity. All committee members are Trustees of the Charity. The Charity had no paid employees during the year and was run entirely by volunteers.

The Charity is registered with the Charity Commission.

Financial Performance: The Charity has been able to maintain a satisfactory level of funding which provides a cushion against the economic pressures being experienced by much of the voluntary sector. With no paid staff and low overheads, existing and new funding can be targeted at the Charity's primary beneficiaries.

The Charity achieved a surplus of £11,569 in the year (£9,310 in 2024). Restricted funds were £35,101 (£25,795 2024) and unrestricted funds £63,309 (£61,046 2024).

The principal sources of income are fees from club nights and charges for outings as well as some donations. Main expenditures are outing and club night costs plus charity and beach insurance premia. As stated previously fixed overheads are very low and the trustees are confident in being able to continue with current activities for the foreseeable future.

Risk Management: The Trustees have assessed the major risks to which the Charity is exposed and, are satisfied that the nature of its operations and cost structure mitigate against exposure to major risks.

The Trustees review risks on an ongoing basis and are satisfied systems and procedures are in place to identify and react to risks which may arise.

Plans for the future: The charity plans to continue to provide services which are of interest and benefit to members. More emphasis will be placed on promoting free transport to health appointments as uptake has been quite low.

Going Concern and reserves: The Trustees believe that the Charity is well placed to meet the challenges of the future and there are no concerns about the Charity's ability to provide its services for the foreseeable future.

The Charity has maintained a suitable level of reserves in the trustees' opinion.

WEST NORFOLK MENCAP

Organisation: The Charity is administered by the Trustees who meet six times per year.

Peter Brown is the Chair and in addition , as a retired accountant, carries out the duties of Treasurer. Assurance of good financial governance is maintained by having all purchase invoices and bank statements reviewed and signed by the Charity's Secretary, Linda Baines.

Marie Brown is Vice-Chair

Cheques require dual signatures and signatories are, Peter Brown, Marie Brown, Linda Baines and Martin Beale. Marie Brown is the wife of Peter Brown and does not sign with him except in emergencies and with prior notification to the other signatories.

The Charity does operate a small Treasurer's Account topped up by £60 per month. Peter Brown and Linda Baines have single authorisation access to this.

Trustees: Nomination for new trustees are considered during the year and those nominated and appointed are re-elected at the first AGM following appointment.

When considering nominations for trustees, requirements for any specialist skills are taken into consideration. New trustees attend an induction meeting to brief them on their legal obligations under charity law, the content of the Memorandum and Articles of Association, the various decision-making processes and the financial position of the charity.

None of the Trustees had any beneficial interest in the charity.

Related Parties: The Charity is affiliated to the Royal Mencap Society and pays a small annual subscription to that body. No funding is received from the Royal Mencap Society.

Peter Brown is a Trustee and Director of the Forward Day Centre Limited. The Charity use the premises of Forward for its Senior Gateway Club upon payment of an agreed rent per session.



FOR THE YEAR ENDED 30 SEPTEMBER 2024

The trustees present their annual report and financial statements for the year ended 30th September.

The accounts have been prepared on a Receipts and Payments basis.

Objectives and activities

The objects of the Charity are to improve the lives and opportunities of children and adults with a learning disability together with their carers and families. To listen to people with a learning disability and to support people with a learning disability in all parts of their lives and to give information and advice.

The main objective during the year continued to be the provision of leisure activities for the Charity's beneficiaries.

Review of charitable activities and achievements for the public benefit

The Charity's aim is to provide of supported leisure activities in order to enable its members to socialise with their peers by attendance at clubs or by taking part in events in a range of mainstream locations and facilities,

The trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

This provision is provided as per the services highlighted in the achievements and performance section as set out below:

Achievements and performance

West Norfolk Mencap provided the following services during the year:

Senior Gateway Club: A club held once every two weeks in the evening for adults with a learning disability in the 18+ age range. A wide variety of activities are held and the club is very popular with 40 to 50 members and has a consistent attendance of more than 30 people. The club is run by 4 volunteers. Where necessary members support staff stay during session but in the majority of cases people are dropped off and then collected at the end of the evening.

Junior Gateway: A smaller club for young people up to the age of 18. This is held in the evening every week during term time. Membership is around 20 and the programme is designed to offer a wide range of games and fun activities. Some of the members do need close supervision to cope with behavioural problems so parents are encouraged to stay when needed.

Befriender Scheme: The Befriender scheme organises outings and social events for members with the aim of helping them to enjoy visits to mainstream locations. Activities include pub nights, meals out, visits to zoos, boat trips on The Broads, cinema visits, Christmas shopping etc. This is another popular service with events being fully booked within a few days of programmes being published

Advocacy: the charity has one volunteer who has trained as an independent advocate and support is provided to members where required

Beach Hut: West Norfolk Mencap is fortunate to own a large beach hut at Old Hunstanton. This is made available free of charge to families, groups and charities with a learning disability connection. When free local schools and other charities are permitted to use it as well. Donations received from users help with maintenance costs.

Financial review

The Charity has been able to maintain a satisfactory level of funding in recent years which has provided protection against the economic pressures felt by many organisations in the voluntary sector. Overheads are very low and no paid staff are employed. This means that all income can be directly used for the Charity's purposes.

No funding is received to cover running costs but the Borough Council Of Kings Lynn and West Norfolk did provide a grant of £7,500 towards a major refurbishment of the Beach Hut which totalled just over £17,000.

WEST NORFOLK MENCAP TRUSTEES' REPORT

FOR THE YEAR ENDED 30 SEPTEMBER 2024

The Norfolk & Waveney Integrated Care Board gave a grant of £10,000 to help promote a greater take up of Learning Disability Annual Health Checks. Subsequently, it was agreed that some of this money could be used to assist with transport to all health appointments. This has been of great benefit to a number of people who do not have easy access to public or private transport.

Reserves at the end of the year totalled £100,717 of which £25,794 were restricted. Running costs excluding refurbishment of the Beach Hut were approximately £12,000 so the Trustees are assured about the financial sustainability of the Charity.

The trustees consider that reserves at this level will ensure that they are able to continue the charity's current activities for the foreseeable future. This level of reserves has been maintained throughout the year.

Principal sources of income and how expenditure meets objectives

The principal sources of income for the Charity are income from outings and fees from club nights as well as donations. Main expenditures are costs of outings, beach hut maintenance and charity and beach hut insurances.

Risk management

The trustees have assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

The Trustees have a risk management review which comprises

- a continuing review of the risks the charity may face;
- the establishment of systems and procedures to mitigate those identified risks; and
- the implementation of procedures designed to minimise the potential impact on the charity should those risks materialise.

Plans for the future

The Charity has identified the following key targets for the coming year:

All Operations – Continue to provide services which are of interest to members and provide support where requested.

Going concern review

The Trustees have no concerns regarding the Charity's ability to provide its services for the foreseeable future.

Structure, governance and management

The Charity is registered with the Charity Commission.

FOR THE YEAR ENDED 30 SEPTEMBER 2024

Organisation

The project is administered by a committee containing up to 12 and no less than 3 Trustees and up to 5 co-opted Trustees. This committee meets 6 times per year.

Peter Brown is the Chair and in addition carries out the duties of Treasurer following the death of Mr Michael Brown (no relation) several years ago. In order to provide financial governance assurance, all purchase invoices and bank statements are reviewed and signed off at each Trustee meeting by the Charity's Secretary Mrs Linda Baines.

Mrs Marie Brown is Vice-Chair.

Cheque signatories are Peter Brown, Marie Brown, Linda Baines and Martin Beale. Cheques require signing by two signatories. Marie Brown is the wife of Peter Brown and does not sign together with Peter Brown except in emergencies and only with prior notification to other trustees.

For reason of operational convenience, the charity operates a small Treasurers Account with Santander Bank to allow for online purchasing. This is topped up by £60 per month and Peter Brown or Linda Baines have single authorisation access to this.

Trustees' induction and training

When considering nominations of Trustees, the requirement for any specialist skills needed are reviewed.

Trustees are encouraged to attend appropriate external training events when these will facilitate the undertaking of their role.


New Trustees attend an orientation meeting to brief them on their legal obligations under charity law, the content of the Memorandum and Articles of Association, the various decision-making processes, the financial plan and recent financial performance of the charity. During this initial orientation programme, they meet other Trustees.

Related parties

The Charity is affiliated to the Royal Mencap Society and pays a small annual subscription to that body. No funding is received from the Royal Mencap Society.

The charity employs no staff and other than the trustees, there are 7 volunteers who support the various activities. Other than the Beach Hut, no premises are used by the charity and everything is run from trustees' homes with appropriate telephone and broadband links.

The trustees' report was approved by the Chair and Vice-Chair.


