REPORT OF THE TRUSTEES FOR THE YEAR ENDED 30 SEPTEMBER 2025

OBJECTS

The Society is established for the purpose of encouraging improvements in livestock by the distribution of premiums, for arranging such other competitions and exhibitions that the Committee may from time to time resolve, and generally for encouraging agricultural improvements of every description.

The Society arranges an annual show for the exhibition of stock and for other exhibitions and competitions, including home produce, handicrafts and horticulture, and awards premiums and other prizes in respect of such exhibitions and competitions. The annual show is held two weeks before the first Tuesday in September at Hawkshead.

REVIEW OF ACTIVITIES

This year's show was a resounding success, due to both excellent weather and the organisational skills of the committee. In addition to record gate entries, sponsorship and trade stand revenue increased substantially, with the creation of a new food hall and craft marquee further boosting income.

To celebrate the Society's 150th year, an after-show Hoedown dance and raffle was organised. The surplus on the night was donated to the Hawkshead Recreation Ground after the year end, to contribute towards new play equipment.

The Society successfully applied for a National Lottery Grant to purchase heavy-duty track mats, in addition to making substantial improvements to the show field's drainage during the year.

FINANCIAL REVIEW

Income for the year increased by 93% to £77,588 which includes a £20,000 grant, compared with £40,264 in the previous year. Show expenditure increased by 99% to £63,162, which includes the purchase of track mats costing £19,989.

The Society made an overall surplus on its activities of £14,426 compared to £8,467 last year, resulting in funds carried forward of £47,862.

In planning and carrying out the charity's activities the Trustees are always aware that such activities must be for the public benefit. As such the Trustees confirm that they have had due regard to the Charity Commission's published guidance on the 'public benefit' motive.

OBJECTS

The Society is established for the purpose of encouraging improvements in livestock by the distribution of premiums, for arranging such other competitions and exhibitions that the Committee may from time to time resolve, and generally for encouraging agricultural improvements of every description.

The Society arranges an annual show for the exhibition of stock and for other exhibitions and competitions, including home produce, handicrafts and horticulture, and awards premiums and other prizes in respect of such exhibitions and competitions. The annual show is held two weeks before the first Tuesday in September at Hawkshead.

REVIEW OF ACTIVITIES

For the second successive year (after something of a hiatus), this year's show was able to go ahead in August 2024.

FINANCIAL REVIEW

Income for the year increased by £11,748 (41%) to £40,264 this year compared to £28,516 last year.

Expenditure increased by 181% from £11,284 to £31,797. However, no meaningful comparison can be made because:

- many suppliers waived their costs last year to enable the Society to continue its activities.
- mat hire costs increased substantially this year due to poor weather conditions.
- the Society purchased a number of assets this year to improve the show moving forward.

This produced a surplus of £8,467 – down from £17,232 last year – resulting in a general reserve carried forward of £33,436.

OBJECTS

The Society is established for the purpose of encouraging improvements in livestock by the distribution of premiums, for arranging such other competitions and exhibitions that the Committee may from time to time resolve, and generally for encouraging agricultural improvements of every description.

The Society arranges an annual show for the exhibition of stock and for other exhibitions and competitions, including home produce, handicrafts and horticulture, and awards premiums and other prizes in respect of such exhibitions and competitions. The annual show is held two weeks before the first Tuesday in September at Hawkshead.

REVIEW OF ACTIVITIES

For the first time in five years, this year's show was able to go ahead on 22 August 2023.

FINANCIAL REVIEW

As there was no meaningful trading income last year (or the previous one) and few operating expenses being incurred, no comparisons are relevant for this year.

The incoming resources and expenditure incurred resulted in a surplus of £17,232 for the year.

PUBLIC BENEFIT

In planning and carrying out the charity's activities the Trustees are always aware that such activities must be for the public benefit. As such the Trustees confirm that they have had due regard to the Charity Commission's published guidance on the 'public benefit' motive.

RESERVES

In recent years the Society's policy has been to maintain cash balances of at least £18,000 – a figure which, it is estimated, would cover any potential loss incurred due to cancellation of a show at short notice at least one and a half times.

Cash balances held exceed this figure at £24,969 but, notwithstanding this, fund raising activities will continue to be held.

The Reserves Policy is reviewed annually by the Committee.

STATEMENT OF TRUSTEES' RESPONSIBILITIES

The Trustees are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and regulations. Law applicable to charities in England and Wales requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the charity's financial activities during the year and of its financial position at the end of the year.

In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.
