Trustees Report 2021-2022

In June 2021 the government lifted some restrictions from the covid virus and we were able to meet in the hall keeping 2 mtr distance.

We have 23 members. We have 12 meetings a year and there are 6 members on the committee and we have 12 committee meetings a year

We resumed our meetings with a Mad Hatters Tea Party and afternoon tea in a box. Members were pleased to get back together after such a long time. Some speakers are still reluctant to return but we enjoyed a talk about work as a magistrate and life working on cruise ships. This year's programme is being finalised

We continued to collect for the food bank until January when the Children's Centre said they hadn't the space to store the goods. We agreed to put our own contributions in the containers provided in the local supermarkets

For a long time we have collected plastic milk bottle tops and we now have a new collector for them. Money made from the sale of these supports the hospice day centre at Dove Cottage.

We also collect blister packs which are collected by man who collects the milk bottle tops

We collect crisp packets too with the silver foil lining but we need 2 kilos before these can be sent off for recycling.

Used stamps are collected and are processed for the leprosy mission. A member is selling pre loved scarves and costume jewellery at our meetings to raise money for Tara's Angels which provides support for woman suffering from domestic abuse and provides starter packs when they move into a safe house.

The Community coffee morning resumed with social distancing and most of our regulars are back enjoying coffee etc on a Thursday morning. The proceeds help towards the upkeep of the hall.

Members enjoyed reading their copy of the Hornblower before our meetings but no one joined any of the meetings on offer.

The hall continues to be booked for activities most days of the week for exercises dance for adults and children meditation parties and monthly meetings of clubs and fund raising events for groups.
