Organisation

The Charity is administered from its principal office and does not have connections with any other organisations other than by receiving donations from or making donations to them.

The Charity's Trustees are responsible for the preparation of the accounts.

Reserves policy

The Charity maintains its funds at a level sufficient to meet its expenses.

Review of progress and achievements

The Charity discharged its functions satisfactorily in relation to its objects.


Review of financial statements and affairs

The Charity continued to receive income from its investment portfolio, managed by Investec.

Purchases of Equities at a cost of £74,986 (2024: £35,486) were made in the year.

Disposals of Equities at original cost of £67,940 (2024: £46,082) were made in the year. The profit on these disposals was £17,724 (2024: £5,592).

The overall value of the investments held by the Charity has decreased due to the downturn in market conditions during the year. This has resulted in a loss on revaluation of £28,330 (2024: *gain on revaluation of £21,885*) which has been recognised in the Receipts and Payment Account. It is the expectation of the Trustees that the value of investments held will continue to fluctuate with the global market.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF THE ANGLO-SWEDISH LITERARY FOUNDATION CHARITY

I report to the trustees on my examination of the accounts of The Anglo-Swedish Literary Foundation ("the Charity") for the year ended 21 March 2025 which comprises the Summary of Receipts and Payments, the Statement of Assets and Liabilities and related notes.

This report is made solely to the charity's trustees, as a body, in accordance with section 145 of the Charities Act 2011. My work has been undertaken so that I might state to the Charity's trustees those matters I am required to state to them in this report and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the Charity and the Charity's trustees as a body, for my work, for this report, or for the opinions I have formed.

Responsibilities and basis of report

As the trustees of the Charity you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("the Act").

I report in respect of my examination of the Charity's accounts carried out under section 145 of the Act and in carrying out my examination I have followed all the applicable directions given by the Charity Commission under section 145(5)(b) of the Act.

An independent examination does not involve gathering all the evidence that would be required in an audit and consequently does not cover all the matters that an auditor considers in giving their opinion on the accounts. The planning and conduct of an audit goes beyond the limited assurance that an independent examination can provide. Consequently, I express no audit opinion on the accounts and my report is limited to those specific matters set out in the independent examiner's statement.

Independent examiner's statement

- accounting records were not kept in respect of the charity as required by section 130 of the Act; or



NOTE 2 - INVESTMENTS VALUATION

Investments have been recognised in the financial statements at £363,266 which represents the Trustees' best estimate of the market value of investments as at 21 March 2025, in accordance with paragraph 10.44 of the SORP. This estimate is based on the market valuation provided by the charity's independent investment management company, Investec, as at 5 April 2025.

The overall value of the investments held by the Charity has decreased due to the recent downturn in market conditions during the year. This has resulted in a loss on revaluation of £28,330 which has been recognised in the Receipts and Payment Account. It is the expectation of the Trustees that the value of investments held will continue to fluctuate with the global market.
