The trustees present herewith their annual report, together with the financial statements of the branch for the year ended 31<sup>st</sup> December 2023.

**RESPONSIBILITIES OF THE TRUSTEES**

The trustees are required to prepare financial statements for each financial year of the branch. In preparing these financial statements the trustees have:

- selected suitable accounting policies and applied them consistently;
- made judgements and estimates that are reasonable and prudent;
- prepared the financial statements on a going concern basis.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Branch and enable the trustees to ensure that the financial statements comply with the Charities Act 2011. The trustees are responsible for safeguarding the assets of the branch and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

**RESULTS**

The excess of expenditure over income for the year was £2,859.

**OBJECTIVES OF THE BRANCH**

The Objectives of the Northallerton, Thirsk and Dales Branch of the R.S.P.C.A. are to promote kindness and prevent suffering of animals, and to do all such lawful acts as the society may consider conducive to these objectives.

The branch is a trust governed by the guidelines of the R.S.P.C.A. and is managed by a committee dedicated to the branch's principal object of animal welfare.

The trustees confirm that they have taken into consideration the Charity Commission's guidance on public benefit when planning the charity's activities.

**THE STRUCTURE OF THE SOCIETY CONSISTS OF:-**

Founded in 1824, the Headquarters are situated in Horsham, it is controlled by a council, elected by the members, from the membership. The country is divided into 3 regions, which are again divided into branches, each having their own charity number.

The branches are run by a committee of local people for the good of the animals in their area, such as assisting the Inspector, re-homing animals that for some reason have to move on, feral cats are caught tested for FELV/FEV and neutered before releasing them back to the place they were caught, hold micro chipping sessions, run neutering campaigns and help with vet bills can sometimes be given.

The trust provides for a maximum of 14 trustees. A viable committee of trustees is a minimum of 7 to include 1 officer. If any new trustees are needed the remaining trustees would appoint them. We look to find new trustees by advertising, newsletters, volunteer centres.

The Chairperson is responsible for the induction of any new trustees and helping them to understand the structure and aims of the R.S.P.C.A. HQ as well as the branch. A copy of the rules and procedures is given to all new trustees. Day to day training is given by the branch, more advanced training is often available from HQ for all trustees.

In recent years we have made significant contributions to the Cat Hub which is a joint effort with four other local branches and has a main purpose of providing a re-homing facility for the cats brought in primarily by the inspectorate. The Cat Hub, when quiet, has also taken many cats which the Branch would ordinarily re-home and is extremely successful in its endeavours and reach to those looking to re-home cats. This would not be possible without the collaboration of neighbouring branches, and we are grateful to them for their support in this venture.

Other than the Cat Hub our main expenditure is the vet bills, we are as committed as every to our neutering programme to help prevent unwanted pets and we are seeing ever increasing numbers of feral animals requiring our help. We have also recently seen an increase in Members of the public who require help towards one off large vet bills for family pets.

We would like to thank the vets that work tirelessly to help and support our cause throughout the year. Additionally, we would like to take this opportunity to thank those who have helped at our fundraising ventures and supported us through donations in both items and time. This help is invaluable to our Branch and those it helps.

The trustees can confirm that in carrying out the above activities, due regard has been paid to Charities Commission guidance on public benefit.

**RESERVES**

The trustees consider the funds held are sufficient for the normal branch activities for animal welfare to continue for the time being, but we are always looking for new fundraising ideas.

The trustees present herewith their annual report, together with the financial statements of the branch for the year ended 31<sup>st</sup> December 2021.

**RESPONSIBILITIES OF THE TRUSTEES**

The trustees are required to prepare financial statements for each financial year of the branch. In preparing these financial statements the trustees have:

- selected suitable accounting policies and applied them consistently;
- made judgements and estimates that are reasonable and prudent;
- prepared the financial statements on a going concern basis.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Branch and enable the trustees to ensure that the financial statements comply with the Charities Act 2011. The trustees are responsible for safeguarding the assets of the branch and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

**RESULTS**

The excess of income over expenditure for the year was £1,547.

**OBJECTIVES OF THE BRANCH**

The Objectives of the Northallerton, Thirsk and Dales Branch of the R.S.P.C.A. are to promote kindness and prevent suffering of animals, and to do all such lawful acts as the society may consider conducive to these objectives.

The branch is a trust governed by the guidelines of the R.S.P.C.A. and is managed by a committee dedicated to the branch's principal object of animal welfare.

The trustees confirm that they have taken into consideration the Charity Commission's guidance on public benefit when planning the charity's activities.

**THE STRUCTURE OF THE SOCIETY CONSISTS OF:-**

Founded in 1824, the Headquarters are situated in Horsham, it is controlled by a council, elected by the members, from the membership. The country is divided into 3 regions, which are again divided into branches, each having their own charity number.

The branches are run by a committee of local people for the good of the animals in their area, such as assisting the Inspector, re-homing animals that for some reason have to move on, feral cats are caught tested for FELV/FEV and neutered before releasing them back to the place they were caught, hold micro chipping sessions, run neutering campaigns and help with vet bills can sometimes be given.

The trust provides for a maximum of 14 trustees. A viable committee of trustees is a minimum of 7 to include 1 officer. If any new trustees are needed the remaining trustees would appoint them. We look to find new trustees by advertising, newsletters, volunteer centres.

The Chairperson is responsible for the induction of any new trustees and helping them to understand the structure and aims of the R.S.P.C.A. HQ as well as the branch. A copy of the rules and procedures is given to all new trustees. Day to day training is given by the branch, more advanced training is often available from HQ for all trustees.

**REVIEW OF DEVELOPMENTS, ACTIVITIES AND ACHIEVEMENTS DURING THE YEAR AND FUTURE DEVELOPMENTS**

In recent years we have made significant contributions to the Cat Hub which is a joint effort with four other local branches and has a main purpose of providing a re-homing facility for the cats brought in primarily by the inspectorate. The Cat Hub, when quiet, has also taken many cats which the Branch would ordinarily re-home and is extremely successful in its endeavours and reach to those looking to re-home cats. This would not be possible without the collaboration of neighbouring branches, and we are grateful to them for their support in this venture.

Other than the Cat Hub our main expenditure is the vet bills, we are as committed as every to our neutering programme to help prevent unwanted pets and we are seeing ever increasing numbers of feral animals requiring our help. We have also recently seen an increase in Members of the public who require help towards one off large vet bills for family pets.

We would like to thank the vets that work tirelessly to help and support our cause throughout the year. Additionally, we would like to take this opportunity to thank those who have helped at our fundraising ventures and supported us through donations in both items and time. This help is invaluable to our Branch and those it helps.

The trustees can confirm that in carrying out the above activities, due regard has been paid to Charities Commission guidance on public benefit.

**RESERVES**

The trustees consider the funds held are sufficient for the normal branch activities for animal welfare to continue for the time being, but we are always looking for new fundraising ideas.

**RISKS**

We see the major risks as:-

Loss of income through error or fraud  
Insufficient trustees for the branch to continue  
Insufficient helpers for fund raising activities  
A sudden large expenditure

The trustees regularly review the financial state of the branch.

**REGULATIONS**

The Branch received no income from contracts, central or local government to deliver services or grants from central or local government.

The Branch does not have policy on paying staff members, as no staff were employed during the year.

The Branch regularly reviews its financial controls, scrutinising the finances and bank accounts. Any changes are discussed and approved prior to implementation at Committee level.
