The trustees present their report with the financial statements of the charity for the year ended 30 November 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and activities

When planning our activities for the year, the trustees have considered the Charity Commissioner's guidance on public benefit. The object and principal activity of the charitable society is to produce and present to the public an agricultural, horticultural and allied show on one day in each year.

The charity's main objective is to present an annual agricultural and horticultural show to the public once every year.

The charity's aims through presenting the show are to:

- Support local farmers in the Keighley district and to promote their role and the benefits of agriculture as a whole.
- Provide greater understanding of agricultural processes and empathy towards farming and the countryside of the surrounding areas of the Keighley District.
- Raise awareness of the local environment and ways in which to protect the environment through sustainability.

As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').





Objectives and activities
