(B) MAKE GRANTS FOR OR TOWARDS PERSONS ENGAGED IN RELIGIOUS WORK WHO ARE IN AGREEMENT WITH THE OBJECTS OF THE PROTESTANT REFORMATION SOCIETY AND WHO REQUIRE REST OR RECREATION DURING CONVALESCENCE OR OTHERWISE.

**Activities:** The objects of the British Society for Promoting the Religious Principles of the Reformation, known as the Protestant Reformation Society, are to advance the Christian religion in accordance with the principles of the Protestant Reformation; and to make grants to persons engaged in religious work who are in agreement with the objects of the Society and who require rest or recreation
