For the year to 28th February 2023**

The trustees present their report and the accounts for the year to 28th February 2022.

Structure, governance and management

The charity, which is an unincorporated association, was founded by schemes of 6th November 1877, 19th February 1946 as varied by scheme of 25th October 1961 and registered with the Charity Commission on 6th July 1964. A new trustee is appointed when required following the agreement of the existing trustees.

Objectives and activities

The objectives of the charity are to provide guides for access across the Kent and Leven estuaries on Morecambe Bay. The activities of the charity are for the public benefit in that they provide assistance with crossing the estuaries safely.

Achievements and performance


During the year the guides once again helped many people cross the estuaries safely.

Financial review

The receipts for the year were £50,809 (2022 - £67,801) and the payments were £65,636 (2022 - £14,679) which resulted in a net excess of payments over receipts of £14,827 (2022 - £53,122 surplus).

The deficit for the year was deducted from the funds brought forward of £255,431 to give a balance at the year end of £240,604.

The trustees aim to keep sufficient reserves to enable them to maintain the property owned by the charity and meet the expenses of running the charity.




