The Trustees present their report and financial statements of the society for the year ended 31st December 2024.

Legal Status

Long Eaton & District Mencap Society – Happivale Social Club is a registered society with the Charity Commission, no.236095.

Long Eaton and District Mencap Society- Happivale Social Club

Happivale provides recreation and leisure activities for people living with a learning disability with the object of improving their mental and physical well-being.

Organisation

The Society is a local Mencap society, which is in partnership with Mencap nationally, but is autonomous and has its own independent constitution. The governing body of the Society is the Executive Committee. It has the power to appoint sub committees as it thinks necessary to meet its responsibilities. The Charities Commission has accepted the Constitution for the organisation.

All Volunteers/Committee members will, during the course of their duties, have the occasion when they will be handling monies in connection with the club and its members

Review of developments, activities, and achievements

The principal components of the Reserve Fund are maintenance of the building, replacement of furniture and equipment, training, and a general fund.

We delivered Club activities on both Monday and Friday evenings (7-9pm) throughout the year. We also held two fundraising fayres, a coffee morning fundraiser, took part in the Long Eaton Carnival Parade, facilitated a bowling trip, pantomime trip and celebrated our 60th Anniversary with a ball and a party.

Trustee Sarah completed a sponsored bungee jump, member Philip completed a 24 hour sponsored silence and a small group of members raised funds with a sponsored walk.

We started to create a new mural for the outside fence, which will be completed and erected in 2025.

Avril Cook continued as Happivale Club Co-ordinator and supported the planning and delivery of activities for members.

For the year ended 31st December 2024

Income & Expenditure

The Charities Income for the period amounted to £34,146.51.

Donations and grants amounted to £13,702 including £300 from Long Eaton Rotary, £259 in memory of Andrew Millington, £1,776 from the Co-Op Fund, £1,000 from the Freemasons of Derbyshire, £1,509 from East Midlands Airport Community Fund, £50 from the Ladies of the Inner Wheel and £100 from Sawley Community Association and £1,000 from member Thomas winning a competition. During the year we have received restricted funds from grant making bodies including £6,788 from Rix Thompson Foundation for 2024 activities and £500 from the British Science Association for expenditure in 2025.

Fund Raising amounted to £4,088 (sponsorship events, coffee morning and fayres) including £386 raised from Jenny's Raffles.

The Happivale Club's subscriptions for the period were £5,818 plus £3,212 contributions for the Long Eaton minibus. The restricted funds income reflects £3,063 towards Ilkeston transport.

The Charities Expenditure for the period amounted to £39,672 giving us an overall deficit of £7,169.91. The deficit is mainly due to receiving a number of grants in 2023 totalling £15,160 that was for expenditure in 2024.

Happivale Club

Happivale Club provides facilities for anyone with learning difficulties over the age of 16 and enables them to participate in social activities which they may otherwise be unable to do. The Club meets every Monday and Friday evening between 7pm and 9pm excluding bank holidays

Currently we have around 70 members with the average attendance of 40 to 50 per session. Friday nights are the most popular. Included in the membership figures are people from Ilkeston (who come on their own minibus) and across the borough. Some of the members may need to bring their own carers, but Happivale itself has around 20 volunteers available to run the activities and fundraise.

The events and activities are based on a monthly programme with a range of engaging and fun activities which the members thoroughly enjoyed including line dancing, boxercise, yoga, science activities and healthy food. The club also celebrates Burns Night, Bonfire Night and had parties and discos for Valentine's Day, Christmas and New Year. Our New Year disco food was provided by the Ladies of the Inner Wheel. Throughout the year we hold a variety of fund-raising activities to increase funds and also receive many generous donations from the local community and organisations.

We continue to work with and are in partnership with Mencap and as such we comply with all the correct working conditions and have installed relevant policies.

Health and Safety and Insurance

During the year the Fire Extinguishers have been serviced, emergency lighting inspected, and batteries replaced. PAT testing was carried out. Fire Drills were held at regular intervals and the First Aid Cabinet checked and restocked. All necessary insurance policies relating to the Charity, its running, and volunteer protection have been undertaken. The Club no longer require a food safety check by the Borough Council but the Club Co-ordinator and a Trustee completed Level 1 Food Hygiene course. All volunteers have current DBS checks with certificates and a number are trained volunteers in first aid.

Reserves Policy and Risk Management

Unrestricted funds are needed:

- (a) To provide funds that can be designated to specific projects to enable them to be undertaken at short notice.
- (b) To cover administration, fund raising and support costs without which the charity could not function.

The Trustees consider it prudent that the unrestricted reserves should be sufficient:

- (a) To avoid the necessity of releasing fixed assets for the Charity's use and
- (b) To cover 3 years' costs.

The level of reserves is monitored and reviewed by the Trustees throughout the year.

We currently have the reserves to cover 2 years expenditure on demand and for a further 3 years at 100 days notice.

The Trustees review the major risks that the charity faces and are satisfied that systems are in place to mitigate our exposure to those major risks.

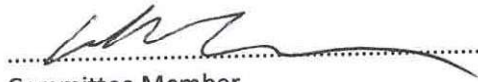

We have been successful with a number of grants from grant making bodies to support activities during the year and on to 2024.

Income & Expenditure

The Charities Income for the period amounted to £37,948.

Donations and grants amounted to £20,411 including £300 from Long Eaton Rotary, £400 in memory of Pamela Peel, £208 from the Erewash Mayor, £100 from the Ladies of the Inner Wheel, £150 from the Friendship Hub and £100 from Sawley Community Association. During the year we have received restricted funds from grant making bodies including £75 Erewash Borough Council, £2,426.05 from Mencap/Sport England, £1,535.96 Community Matters for delivery of activities during this financial year as well as £10,000 Awards for All, £500 British Science Association and £4,660 from Derbyshire Mind for activities and spend in 2024.

We continue to receive a contribution towards transport costs from the Long Eaton members who travel in our minibus.

Fund Raising amounted to £1,602 including £374.10 raised from Jenny's Raffles. Jenny has now raised £1,539.05 towards equipment and activities for the club.

The Happivale Club's subscriptions for the period were £5,954 plus £3,220 contributions for the Long Eaton minibus. The restricted funds income reflects £2,874 towards Ilkeston transport.

The Charities Expenditure for the period amounted to £32,134 giving us an overall surplus of £5,785. Although to note, some funds received £15,160 are for expenditure in 2024.

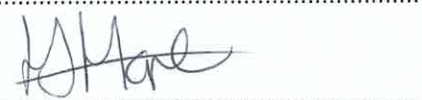

The Trustees present their report and financial statements of the society for the year ended 31st December 2022.

Legal Status

Long Eaton & District Mencap Society – Happivale Social Club is a registered society with the Charity Commission, no.236095.

Long Eaton and District Mencap Society- Happivale Social Club

Happivale provides recreation and leisure activities for people living with a learning disability with the object of improving their mental and physical well-being.

Organisation

The Society is a local Mencap society, which is in partnership with Mencap nationally, but is autonomous and has its own independent constitution. The governing body of the Society is the Executive Committee. It has the power to appoint sub committees as it thinks necessary to meet its responsibilities. The Charities Commission has accepted the Constitution for the organisation.

All Volunteers/Committee members will, during the course of their duties, have the occasion when they will be handling monies in connection with the club and its members

Review of developments, activities, and achievements

The principal components of the Reserve Fund are maintenance of the building, replacement of furniture and equipment, training, and a general fund.

The Club was open as normal through the year following the previous two years that were impacted by Covid 19 pandemic. We delivered Club activities on both Monday and Friday throughout the year. We held two fundraising fayres and a day trip to Hull (The Deep and Streetlife Museum). We also celebrated being back together with a Summer ball that was funded through a donation from Sawley Golf Club in 2021. The event was a great success, and everyone enjoyed dressing up in their best party outfits.

Mr V T Zakarian continued as the Club Leader until the end of March 2022. Mr V T Zakarian gave notice of his retirement in January and joined the committee in April 2022.

After a review, and to support development and sustainability of the Charity, Avril Cook was appointed as Happivale Club Co-ordinator and started the role as a self employed post in August 2022.

Income & Expenditure

The Charities' Income for the period amounted to £25,152.

Donations and grants amounted to £8,023 including £5,000 from Erewash Mental Health Association Ltd, £497.20 in memorium Les Raynor, £1,000.26 from John Hemsley's legacy, smaller donations from Inner Wheel, Long Eaton Rotary and Sawley Community Association, and a restricted 'Happivale Happy Healthy living' Grant from Derbyshire County Council of £997.

We continue to receive a contribution towards transport costs from the Long Eaton members who travel in our minibus.

Fund Raising amounted to £1,422 including £329 raised from Jenny's Raffles. Jenny has now raised £1,164.95 towards the new games tables which cost £1,955 in 2020.

The Happivale Club's subscriptions for the period were £6,117 plus £2,430 contributions for the Long Eaton minibus. The restricted funds income reflects £2,803 towards Ilkeston transport. After some considerable effort we eventually received and paid invoices for the Ilkeston minibus.

The Charities Expenditure for the period amounted to £26,344 giving us an overall loss of £1,192. This is not too much of a worry in itself but is more concerning when considering the sizeable donations we gratefully received, but cannot be relied on.

Happivale Club

Happivale Club provides facilities for anyone with learning difficulties over the age of 16 and enables them to participate in social activities which they may otherwise be unable to do. The Club meets every Monday and Friday evening between 7pm and 9pm excluding bank holidays, and also runs a trip each year.

Currently we have around 70 members with the average attendance of 40 to 50 per session. Friday nights are the most popular. Included in the membership figures are people from Ilkeston (who come on their own minibus) and across the borough. Some of the members may need to bring their own carers, but Happivale itself has around 16 volunteers available to run the activities and fundraise.

The events and activities are based on a monthly programme and include discos, pool, darts, cookery, art projects, bingo and food nights. The club also celebrates Burns Night, Bonfire Night and has parties and discos for Valentine's Day, Christmas Day and New Year. Our New Year disco food was provided by the Ladies of the Inner Wheel. Throughout the year we hold a variety of fund-raising activities to increase funds and also receive many generous donations from the local community and organisations.

We continue to work with and are in partnership with Mencap and as such we comply with all the correct working conditions and have installed relevant policies.

Health and Safety and Insurance

During the year the Fire Extinguishers have been serviced, emergency lighting inspected, and batteries replaced. PAT testing was carried out. Fire Drills were held at regular intervals and the First Aid Cabinet checked and restocked. The central heating boiler has been serviced. All necessary insurance policies relating to the Charity, its running, and volunteer protection have been undertaken. The Club has passed its food safety check by the Borough Council. All volunteers have current DBS checks with certificates.

Reserves Policy and Risk Management

Unrestricted funds are needed:

- (a) To provide funds that can be designated to specific projects to enable them to be undertaken at short notice.
- (b) To cover administration, fund raising and support costs without which the charity could not function.

The Trustees consider it prudent that the unrestricted reserves should be sufficient:

- (a) To avoid the necessity of releasing fixed assets for the Charity's use and
- (b) To cover 3 years' costs.

The level of reserves is monitored and reviewed by the Trustees throughout the year.

We currently have the reserves to cover 1 years expenditure on demand and for a further 2 years at 100 days notice.

The Trustees review the major risks that the charity faces and are satisfied that systems are in place to mitigate our exposure to those major risks.

Results

The results for the year and the Charities financial position at the end of the year are shown in the attached financial statements.

Independent Examiner

A resolution to re-appoint RWB Chartered Accountant as the independent examiner for the ensuing year will be proposed at the AGM.

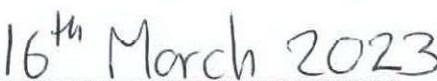
