Achievements and performance

During the year the Trust made grants to 26 (2024: 16) institutions totaling £90,873 (2024: £73,629) in furtherance of the charitable objects of the Trust.

Financial review

During the year, the Trust received total incoming resources of £86,092 (2024: £66,466), comprising investment income of £85,065 (2024: £64,287) and bank interest of £1,027 (2024: £2,179) and expended £122,131 (2024: £100,269). The net expenditure for the year before gains and losses on investments was £36,039 (2024: £33,803).

Reserves policy

Reserves are retained at a level sufficient to generate income for distribution by way of grants at the discretion of the trustees.

Investments

The investment criteria are regularly discussed by the trustees. Their objective is biased towards an income return with investments managed on a risk-averse basis. The trustees are satisfied with the performance of the Trust's investments. The trustees have wide powers of investment.
